REQUEST FOR APPROVAL OF WITHDRAWAL


Aurora Media, LLC ("Aurora"), permittee of an unbuilt station on Channel 233C, Caliente, Nevada (*see* FCC File No. BNPH-20050103AFD), hereby requests approval to withdraw the Application for Review filed on Dec. 1, 2006 proposing to reallocate Channel 233C from Caliente to Moapa, Nevada, and modify Aurora's construction permit accordingly. Concurrently herewith, Aurora is submitting an application on FCC Form 301 to change city of license to Moapa, Nevada, pursuant to the rules adopted in the Report and Order in MB Docket No. 05-210, *Revision of Procedures Governing Amendments to FM Table of Allotments and Changes of Community of License in the Radio Broadcast Services*, FCC 06-163, released November 29, 2006. Aurora therefore desires to withdraw its Application for Review and the expression of interest filed in connection therewith, and requests dismissal of the Application for Review and termination of this proceeding.

A sworn declaration pursuant to Section 1.420(j) of the Commission's Rules is attached regarding this withdrawal.


DECLARATION OF SCOTT G. MAHALICK

I, Scott G. Mahalick, declare as follows:

1. I am Manager of Aurora Media, LLC ("Aurora"), which holds a construction permit for an unbuilt FM radio station on Channel 233C at Caliente, Nevada (File No. BNPB-20050103AFD).
2. On or about March 5, 2005, I caused to be filed on behalf of Aurora, a Petition for Rule Making ("Petition") proposing to reallocate Channel 233C from Caliente to Moapa, Nevada, and to modify Aurora's CP accordingly. The rule making was assigned MB Docket No. 05-146. Aurora submitted the required expression of interest in the proposed reallocation.
2. The Petition was denied on May 26, 2006. Aurora filed a Petition for Reconsideration, which was denied on October 13, 2006. Aurora filed an Application for Review, which is pending.
3. Aurora has decided to file an application pursuant to rules adopted in MB Docket No. 05-210, *Revision of Procedures Governing Amendments to FM Table of Allotments and Changes of Community of License in the Radio Broadcast Services*, FCC 06-163, released November 29, 2006, requesting a change in city of license of the unbuilt station from Caliente to Moapa, Nevada, and therefore withdraws its Petition and requests that the Commission dismiss the Petition and the pending Application for Review and terminate MB Docket No. 05-146.
4. I hereby declare that neither Aurora nor any of its principals has received or will receive any money or other consideration in exchange for the withdrawal of the Application for Review and/or Aurora's expression of interest in the proposed reallocation.

I declare, under penalty of perjury, that the foregoing is true and correct.
