

MOTION TO STRIKE COMMENTS OF CLEAR CHANNEL COMMUNICATIONS, INC.

Mt. Wilson FM Broadcasters, Inc. (hereinafter “Mt. Wilson”), licensee of station KMZT-FM, Los Angeles, California and standard broadcast station KKGO, Beverly Hills, California, by and through its counsel, respectfully requests that the Comments and Reply Comments of Clear Channel Communications, Inc. (hereinafter “Clear Channel”) be stricken. In support thereof, the following is stated.

Motion to Strike Clear Channel Comments

The Mt. Wilson Comments in this proceeding were timely filed on October 23, 2006. The Clear Channel Comments were timely filed on October 23, 2006. Subsequent to the filing of the Clear Channel Comments, the sale of Clear Channel to Bain Capital Partners and Thomas H. Lee Partners was publicly announced on or about November 16, 2006. An application for transfer of control was filed with the FCC on December 12, 2006 and reported as "Accepted for Filing" on a Commission Public Notice released December 20, 2006. Whatever the position is of the new ownership as to the issues raised in the Further Notice of Proposed Rule Making, (2006 Quadrennial Regulatory Review, MB Docket No. 06-121), such position has never been filed in this proceeding and is not a matter of record either as of the October 23, 2006 Comment filing date or the January 16, 2007 Reply Comments filing date.¹ The views and positions of the old Clear Channel ownership do not constitute (at this untimely date) the views and positions of the new ownership. In short, the Comments of the old Clear Channel ownership are now

¹ Control (i.e., programming, etc.) of Clear Channel will remain vested in the old ownership until Closing. However, since the old ownership has publicly announced its intention to divest its controlling interest (irrespective of the identity of the new ownership), the position of the old ownership is irrelevant to rules which will become effective at a future date.

wholly irrelevant to the instant rulemaking proceeding and, accordingly, should be stricken from the record.
