




PETITION FOR EXEMPTION FROM CLOSED CAPTIONING REQUIREMENTS

Introduction

First United Methodist Church is located in the Old Cloverdale Historic District of Montgomery, Alabama. It was founded in 1829 as Court Street Methodist Church in downtown Montgomery and moved to its present location in 1931. "A caring community of believers, growing in faith and sharing the transforming love of Jesus Christ" is the vision statement of the church. It serves not only its own congregation but also many mission activities in the local community and around the world. Additional literature describing many of the activities of the church is attached.

The Sunday morning worship service is televised live each week at 11:00 on the local NBC affiliate, WSFA TV. It is also carried in a delayed version later in the week on the Frazer United Methodist Church network. Our television ministry is viewed by a large audience in the local area and surrounding counties each week and is a vital part of the mission of the church. Many of these viewers are shut-ins, some abiding in nursing homes and other facilities and are unable to physically attend worship at any church.

The broadcast is produced internally here at the church and filmed using two TV cameras owned by the church. Volunteers operate the cameras, and two people are paid a fee for handling the production room equipment and audio portion of the broadcast, which is fed via microwave to the TV station, WSFA.

For the reasons set forth below, First United Methodist Church of Montgomery hereby requests an undue burden exemption from the closed captioning rules for the church's Sunday Morning Worship Service, pursuant to Rule 79.1(f) of the Commission's rules.

Nature and Cost of Closed Captions

First United Methodist has received pricing from a recommended captioning provider, Caption Reporters, in Maryland. Their cost per hour is \$150.00. Another company, NCI, located in Virginia, quoted \$195.00 per hour. The lower of the two would increase our in-house production costs by 42.8%. Added to this will be other costs, such as phone lines to connect with the captioning companies, along with time of service on the lines. This could drive the costs up to as much as \$400.00 per week or more.

Impact on the Operation of the Program Provider

The weekly production costs of our broadcasts amount to \$350.00, along with a weekly cost of \$900 to televise over WSFA TV. This is a tremendous financial drain on our resources. To add closed captioning at a minimum cost of \$150.00 per week would increase our total TV ministry expense by at least 12%. There will undoubtedly be other costs such as phone lines to connect with the captioning company, plus time of service on these lines. We estimate a total weekly cost of \$400.00 or more. To have to undergo such an increase would create an undue burden on the church.

Financial Resources of the Program Provider

The church is a non-profit religious institution, operating within the connectional system of the United Methodist Church. It is exempt from federal income taxes under Section 501 (c) (3) of the Internal Revenue Code. Its primary source of income is from donations from its members. The additional costs associated with including Closed Captioning with our weekly broadcasts would seriously affect our ability to properly maintain this already planned area of expense, possibly necessitating the diversion of funds from other areas of ministry, and thereby creating a hardship on that particular ministry area.

Type of Operations of the Program Provider

First United Methodist is a church, a non-profit organization, as described above. Its purpose is to bring people to Jesus Christ and to minister to God's people within the community. It also supports various missionaries around the world through gifts from its membership.

Other Factors

First United Methodist Church believes that the local, non-news exemption to the closed captioning rules applies to our Sunday Morning Worship Services. These worship Services are produced and distributed live locally only, and the sermons of First United Methodist Church are of primarily local public interest. The episodes are not news, and the electronic newsroom technique is not available. Notwithstanding the applicability of the exemption, we have filed this petition in an abundance of caution and for the purpose of establishing certainty.

Conclusion

As shown by this petition and its attachments, the Commission should grant a waiver of the closed captioning requirements in this case, because requiring closed captioning would create an undue burden. The costs of closed captioning would be excessively high and would have a significant impact on the Petitioner's operations. The Petitioner's type of operations and financial resources are different in kind and magnitude from a mainstream programming provider. Because of the difficulty and expense of providing

closed captions, a waiver under Rule 79.1(f) is warranted. If more information is needed, please contact me at the address provided below.

Independent Accountants' Report

We have audited the accompanying statement of assets, liabilities, and net assets - modified cash basis of First United Methodist Church (a non-profit organization) as of December 31, 2004, and the related statements of revenues, expenses and other changes in net assets - modified cash basis, and cash flows - modified cash basis for the year then ended. These financial statements are the responsibility of the Organization's management. Our responsibility is to express an opinion on these financial statements based on our audit.

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation. We believe our audit provides a reasonable basis for our opinion.

As described in Note 1, the financial statements are presented on the modified cash basis, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America.

In our opinion, the financial statements referred to above present fairly, in all material respects, the assets, liabilities, and net assets of First United Methodist Church as of December 31, 2004, and the results of its revenues, expenses and other changes in net assets and its cash flows for the year then ended on the basis of accounting described in Note 1.

Our audit was made for the purpose of forming an opinion on the financial statements referred to in the first paragraph taken as a whole. The accompanying information on pages 13 - 51 is presented for purposes of additional analysis and is not a required part of the financial statements. Such information has been subjected to the auditing procedures applied in the audit of the financial statements referred to above; and, in our opinion, the information is fairly stated in all material respects in relation to the financial statements taken as a whole.

NOTES TO FINANCIAL STATEMENTS

FIRST UNITED METHODIST CHURCH

Note 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Nature of Activities - The Church is a United Methodist church located in Montgomery, Alabama. The Church's revenues are derived from contributions made by individuals.

Basis of Accounting - The financial statements of the Church are prepared on the modified cash basis of accounting. Under this basis of accounting, only revenue collected, costs and expenses paid, assets and liabilities arising as a result of cash transactions and recording depreciation of assets that had been acquired for cash are recognized.

Basis of Presentation - In accordance with professional standards, the Church reports information regarding its assets, liabilities, and net assets and revenues, expenses, and other changes in net assets according to three classes of net assets: unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets.

Cash and Cash Equivalents - For purposes of the statement of cash flows, the Church considers all highly liquid investments with an initial maturity of three months or less to be cash equivalents.

Land, Buildings, and Equipment - In accordance with professional standards, the Church recognizes depreciation on all long-lived tangible assets including houses of worship. Because historical costs and records were not available for the original buildings and improvements, some of which date back to the 1930's, insured values were used to record buildings and improvements constructed prior to 1981. Real property additions and improvements acquired after 1980 are recorded at historical cost. All furniture, fixtures and equipment are recorded at cost. Depreciation is provided for in amounts sufficient to relate the cost of depreciable assets to operations over their estimated service lives, using the straight-line method.

Income Tax Status - The First United Methodist Church of Montgomery is exempt from federal and state income taxes under Internal Revenue Code Section 501(c)(3).

Donated Property - Donations of property are recorded at fair market value when received.
