
Dear Ms. Dortch:

Regulatory Stability Means Competition, Lower Prices, and Better Services for Consumers and Businesses

- **Competitive carriers have enjoyed nearly two years of regulatory stability** and have responded by investing billions of dollars in new facilities and services

- **Recent AT&T/BellSouth merger conditions ensure stable regulatory environment** through the end of the decade
 - Rate freeze for telco network elements used by competitive carriers until 2010
 - No forbearance petitions with the FCC during this time
 - In short, the largest incumbent phone company has agreed that no further tinkering with pro-competitive network access requirements is needed

- **FCC has already deregulated new broadband facilities of telcos**
 - Telcos now have full parity with cable company broadband services


- **Further fine tuning of telecom regulation will only bring back uncertainty, new waves of litigation and stalled investment**
