Petition for Exemption from Closed Captioning Requirements-Section 79.1 (f)

World Global Ministries is a non-profit religious organization which is located on 69 King Ave., Newark, Ohio 43055. The church produces one 30 minute program a week. The broadcast is a local Sunday Service edited down to meet time requirements. The program is aired on ABC 6.2 and FOX 28. The program utilizes in-house personal and mostly volunteers to run the cameras. We pay additional outside help for editing of the program.

Through the media of broadcasting World Global Ministries for the past 4 months has been able to reach past the walls of the church to minister to those that are shut in and to those that are incarcerated with Gospel of Jesus Christ.


We, World Global Ministries requests an undue burden exemption from closed captioning rules for World Global Ministries TV program, pursuant to section 79.1 of the commission's rules.

World Global Ministries is a ministry that is focused on raising up people to their fullest potential so that they can fulfill the call of God on their lives. The ministry reaches the community through the broadcasts and through the many ministries of the church offers for example the food pantry feeds over 95 families a month outside of the body of members.

As shown by this petition and it's attachments the Commission should grant a waiver of the closed captioning requirements in this case, because requiring closed captioning would create an undue burden. The cost of captioning would highly impact the Petitioner's operation. The Petitioner's operations and financial resources are different in kind and magnitude from a mainstream programming provider. Because of this

significant difficulty and expense of providing closed captions, a waiver under 79.1 (f) is warranted. If more information is needed, please contact me at the address provided below.




