Petitioner Kristin Brooks Hope Center (“KBHC”), by its undersigned attorneys, hereby withdraws, with prejudice, its December 15, 2006 Petition for Cease and Desist Order and for Sanctions (the “Petition”) filed against Patriot Communications LLC (“Patriot”) and McLeodUSA Inc. (“McLeodUSA”) in the above referenced docket and all KBHC pleadings and correspondence filed in support thereof.

The Petition is moot because KBHC, Patriot and McLeodUSA have achieved a definitive settlement of the private contractual dispute that gave rise to the Petition. KBHC therefore withdraws its Petition with prejudice.
