To Whom it May Concern:

This letter of appeal is on behalf of the Mason Public School District, BEN 131230, regarding the Funding Commitment Decision Letter for Funding Year 2006. Mason Public School District (MPSD) Form 471 Application Number is 502936. MPSD is appealing the decisions on the following FRNs:

FRN 1421791, AllTel Communications, SPIN: 143008900
FRN 1421869, Michigan Bell Telephone Company, SPIN: 143001727
FRN 1421894, Metronet Telecom, Inc., SPIN: 143004352
FRN 1421982, Millennium Digital Media, L.L.C., SPIN: 143006067
FRN 1440639, Nextel West Corp., SPIN: 143000893

The exact text on each of these decisions for the five FRNs listed above is:

"Funding Commitment Decision: \$0.00 - 28 Day Period Violated

Funding Commitment Decision Explanation: The Form 471 application was signed and/or submitted prior to the expiration date of the 28-day waiting period from the day of the posting of the form 470 to the SLD Web Site."

MPSD feels that a waiver of the 28-day waiting period should be granted because of extenuating circumstances that could not be avoided even with careful planning.

For Funding Year 2006, as MPSD has successfully done in prior years in an effort to be punctual, we performed the preliminary data entry portion of the 471 online for the anticipated winning vendors one business day prior to the 28-day waiting period. As we had also successfully completed in prior years, we would then go back online after the 28-day waiting period and if the anticipated winning vendors had actually won, we would then perform the separate step to "Certify Complete" and finish the 471 filing. In the very unlikely event that the anticipated winning vendor had lost, we would then simply delete the online information for that particular FRN and enter the new vendor information and then perform the "Certify Complete".

However, for this submission, even though we performed the preliminary data-entry portion as usual, and, to the best of our ability we carefully read and processed the information messages displayed to us online, when we clicked on the "SUBMIT" button for each FRN, we had no idea that the process had changed and we were actually doing a two-step process and in essence performing a "Certify Complete" also. We thought that the purpose of the "SUBMIT" button was to simply save all of the online data that we had entered. As we have stated before, we then believed that we would go back online after the 28-day waiting period and verify that all of the vendor information was complete and then perform the "Certify Complete".

For services that MPSD felt uncertain about whom the winning vendor would be, we would not perform this preliminary data entry. This was the case for pager services for Funding Year 2006. This service was on the same Form 471 Application Number 502936 as the other services that were denied. This pager service is FRN 1460752, American Messaging (AM), Inc., SPIN 143003128. At the very least, the fact that we waited to enter the pager service vendor information after the 28-day period demonstrates two things. The first is that we only performed the preliminary data entry on the other services as an effort to be punctual. The second thing it demonstrates is that we were definitely confused and did not realize that the process of submitting an FRN had changed from a two-step process to a one-step process.

As MPSD is sure you are aware, Michigan's economy is struggling severely and its schools have felt the pain. MPSD believes that because of the special circumstances explained above, it would serve the public interest of our school district to grant a waiver of the 28-day waiting period.

A GUIDE TO THE FUNDING COMMITMENT REPORT

A report for each funding request in your application is attached to this letter. We are providing the following definitions for the items in that report.

FORM 471 APPLICATION NUMBER: The unique identifier assigned to a Form 471 application by USAC.

FUNDING REQUEST NUMBER (FRN): A Funding Request Number is assigned by USAC to each Block 5 of your Form 471. This number is used to report to applicants and service providers the status of individual funding requests submitted.

FUNDING STATUS: Each FRN will have one of the following statuses:

1. "Funded" - the FRN is approved for support. The funding level will generally be the level requested unless USAC determined during the application review process that some adjustment is appropriate.
2. "Not Funded" - the FRN is one for which no funds were committed. The reason for the decision will be briefly explained in the "Funding Commitment Decision Explanation." An FRN may be "Not Funded" because the request does not comply with program rules, or because the total amount of funding available for the Funding Year was insufficient to fund all requests.
3. "As Yet Unfunded" - a temporary status assigned to an FRN when USAC is uncertain at the time the letter is sent about whether sufficient funds exist to make commitments for requests for Internal Connections Other than Basic Maintenance or Basic Maintenance of Internal Connections at a particular discount level. CONTRACT NUMBER: The number of the contract between the eligible party and the service provider, if a contract number was provided on your Form 471.

BILLING ACCOUNT NUMBER: The account number that your service provider has established with you for billing purposes, if a Billing Account Number was provided on your Form 471.

SERVICE START DATE: The Service Start Date for this FRN from Block 5, Item 19 of your Form 471.

CONTRACT EXPIRATION DATE: The Contract Expiration Date for this FRN from Block 5, Item 20b of your Form 471, if a contract expiration date was provided on your Form 471.

SITE IDENTIFIER: The Entity Number listed in Form 471, Block 5, Item 22a for "site specific" FRNs only.

NUMBER OF MONTHS RECURRING SERVICE PROVIDED IN FUNDING YEAR: The number of months of service that has been approved for the funding year, for recurring services.

ANNUAL PRE-DISCOUNT AMOUNT FOR ELIGIBLE RECURRING CHARGES: Eligible monthly pre-discount amount approved for recurring charges multiplied by number of months of recurring service approved for the funding year.

ANNUAL PRE-DISCOUNT AMOUNT FOR ELIGIBLE NON-RECURRING CHARGES: Annual eligible non-recurring charges approved for the funding year.

PRE-DISCOUNT AMOUNT: Amount in Form 471, Block 5, Item 23I, as determined through the application review process.

DISCOUNT PERCENTAGE APPROVED BY USAC: The discount rate that USAC approved for this service.

FUNDING COMMITMENT DECISION: The total amount of funding that USAC has reserved to reimburse your service provider for the approved discounts for this service for this funding year. It is important that both you and your service provider recognize that USAC should be invoiced and that disbursement of funds will be made only for eligible, approved services actually rendered.

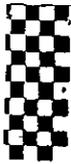
