REQUEST OF BIG BEND TELEPHONE COMPANY, INC., FOR AUTHORITY TO INCLUDE IN ITS RATE BASE THE INTERSTATE PORTION OF THE PREPAID POST-EMPLOYMENT HEALTH BENEFITS RECORDED IN ACCOUNT 1410, OTHER NONCURRENT ASSETS

On January 26, 2007, Big Bend Telephone Company, Inc. (Big Bend) filed a letter requesting authority to include in its rate base the interstate portion of the prepaid post-employment health benefits recorded in Account 1410, Other noncurrent assets.¹ Big Bend uses a pre-funded trust for the retirement benefits, which has a pre-paid balance relating to post-retirement health benefits of \$476,429 as of December 31, 2005.

Interested parties may file comments on or before **March 12, 2007**, and reply comments on or before **March 22, 2007**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.² Comments filed through the ECFS can be sent as an electronic file via the Internet to <http://www.fcc.gov/cgb/ecfs/>. Generally, only one copy of an electronic submission must be filed.³ In completing the transmittal screen, commenters should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number, in this case

WC Docket No. 07-33. Parties may also submit an electronic comment by Internet e-mail. To get filing instructions for e-mail comments, commenters should send an e-mail to ecfs@fcc.gov, and should include the following words in the body of the message, "get form <your e-mail address>." A sample form and directions will be sent in reply. Parties who choose to file by paper must file an original and four copies of each filing. Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail (although we continue to experience delays in receiving U.S. Postal Service mail). **Parties are strongly encouraged to file comments electronically using the Commission's ECFS.**

The Commission's contractor, Natek, Inc., will receive hand-delivered or messenger-delivered paper filings for the Commission's Secretary at 236 Massachusetts Avenue, NE, Suite 110, Washington, DC 20002.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.⁴ Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one- or two-sentence description of the views and

arguments presented generally is required.⁵ Other requirements pertaining to oral and written *ex parte* presentations are set forth in section 1.1206(b) of the Commission's rules.⁶
