Dear Mr. Crawford:

This refers to a petition for rule making you filed proposing the allotment of Channel 295A to Boswell, Oklahoma. To accommodate that allotment, you requested that Station KHTT(FM), Channel 295C, Muskogee, Oklahoma, be reclassified as a Class C0 facility.

An Order to Show Cause was issued to Renda Broadcasting Corporation of Nevada ("Renda"), the licensee of FM Station KHTT, to show cause why its license should not be modified to specify operation as a Class C0 station because it was operating below minimum Class C standards.<sup>1</sup> Renda responded by filing an acceptable construction permit application for FM Station KHTT to operate with minimum Class C facilities by increasing the antenna height to at least 451 meters height above average terrain (HAAT). On February 22, 2007, the Commission granted Renda's construction permit application. Therefore, the petition for rule making proposing the allotment of Channel 295A at Boswell, Oklahoma, is hereby dismissed pursuant to the Note to Section 1.420 of the Commission's Rules.

PETITION FOR RULE MAKING

Pursuant to 47 C.F.R. 1.401, Charles Crawford respectfully petitions the FCC to institute a Rule Making proceeding to amend the FM Table of Allotments to add Channel 295A at Boswell, Oklahoma.

DISCUSSION

Petitioner respectfully submits that the public interest would be served by allocating Channel 295A to Boswell, Oklahoma as that community's first competing FM service.<sup>1</sup> Boswell is an incorporated city with a population of 703 people.<sup>2</sup> Boswell has its own mayor, its own police department, Steve Heming chief of police, city offices, post office, volunteer fire department, and a

number of local churches. The proposed channel 295A will provide additional diversity and an outlet for local self-expression to Boswell residents and therefore is in the public interest.

In order for Channel 295A to be allotted to Boswell, Oklahoma, station KHTT Channel 295C at Muskogee, Oklahoma must be reclassified to a C0. (See, Attachment A, Request to Reclassify Statement)

Attached hereto is a channel study confirming that Channel 295A can be allocated to Boswell, Oklahoma, consistent with the FCC's FM separation rules. See revision of FM Assignment Policies and Procedures, 90 FCC 2d 88 (1992). (See, Attachment B)



Request to Reclassify  
Station KHTT(FM), Muskogee, Oklahoma  
Pursuant to MM Docket 98-93

Radio Station KHTT(FM), Muskogee, Oklahoma is licensed to Renda Broadcasting Corporation of Nevada, 900 Parish St., 4<sup>th</sup> Floor, Pittsburgh, PA 15220, (Facility ID 55704), FCC File No. BLH 19820914AJ. The facility operates with a power of 100 kilowatts with center of radiation 308 meters height above average terrain. The above captioned Docket 98-93 provides the mechanism to automatically downgrade a Class C facility to Class C0 when a demand is made for the spectrum, as is the case here. Charles Crawford respectfully requests that the license of Radio Station KHTT (FM) be modified to specify operation on FM Channel 295C0 instead of on FM Channel 295C in accordance with the above Docket which provides for such downgrades when a demand for the unused spectrum is made, as is the case here.

Charles Crawford, the proponent of Channel 295A at Boswell, Oklahoma in accordance with the above Docket, formally requests that the Commission reclassify Radio Station KHTT (FM) as a Class C0 facility. Charles Crawford certifies that no alternative channel is available for the service he proposes at Boswell, Oklahoma as is proposed in the Petition for Rule Making. A copy of this Petition for Rule Making is being served on Renda Broadcasting Corporation of Nevada, as is required in the above Docket.






