



Request for Review of USAC Decision on Appeal

To Whom It May Concern:

An appeal of USAC's decision is requested for Queen Anne's County Public Schools (QACPS) for filing year 2006-07.

During this filing year, Robert Lathroum, the original filer for USAC/SLD documents, retired from employment. At this same time, his office contents were relocated outside the main building to portable offices at 202 Chesterfield Avenue, Centreville, MD 21617. In the process, we feel pieces of key information had gone missing, or were undeliverable. To the best of my ability, I have outlined a time line of the documents we have located in his files and attached copies where appropriate. In speaking with a USAC/SLD representative, I had found that on original documents our fax number was listed incorrectly, in addition to, the direct phone number and fax number for Robert Lathroum on many of his documents.

Queen Anne's County originally filed the Form470 electronically on November 11, 2005 by Robert Lathroum. I have attached a copy of his signed certification of the same date. Dated November 14, 2005 we received a "Form470 Receipt Notification Letter".

After waiting a week longer than the 28 day waiting period, Form 471 was then filed by Robert Lathroum electronically under application number 333420000550950 in December of 2005. The paper certification was mail on 12/22/05 with a certified receipt that we have tracked and confirmed as being received on 12/27/05 at 3833 Greenway

Drive, Lawrence, KS 66046. I have copies of these documents and they are attached because I worked with Robert Lathroum in training to file these documents.

Dated January 9, 2006 we received a "Form471 Receipt of Acknowledgement Letter" stating that the certification was received and corrections could be made if needed. We did not need to make any corrections to my knowledge.

On January 27, 2006 a request was received to certify the original Form470. In February, I followed the directions to attempt to recertify on Robert Lathroum's behalf since he was no longer employed by our school system at that time. To my knowledge, this was a recertify of what was already mailed on November 11, 2005. In addition, copies Form471 certification pages were again mailed to Lawrence, KS and I certified on line on February 14, 2006. We also received another "Form 471 Receipt of Acknowledgement" letter.

On February 20, 2006 I received another "Form470 Receipt Notification Letter" for the 2006-07. However, it came to me with a different application number: 341610000582867.

It was not until May, 2006 that I heard from USAC/SLD when a PIA was reviewing our application for compliance. I responded to her questions via facsimile, sending copies of all documents as well as a paragraph explaining the duplication of 470/471s due to the turnover in our department since I was unable to locate a return receipt for the certification. We did not intend to file the forms again, only to submit proof of certification of those filed in November, 2005 and January, 2006 by Robert Lathroum.

An attempt to follow up with the PIA via phone, and then later by email on August 1, 2006 was made, without a return of my call or email.

In October, 2006, I called USAC/SLD just to follow up on our process. I was assigned case number 21-495043 and was told that per a letter dated September 19, 2006 our funding had been 'Denied' because certification of Form 470 was not filed by the closing window. I explained that all originals were filed and I was asked to resubmit those documents electronically in February. Again, to my knowledge I was just recreating, or refileing documents on behalf of Mr. Lathroum, not starting the process from the beginning. So in my assessment of our conversation, I did not know I was required, nor was I told, to wait another 28 days before resubmitting a copy of the 471, being under the impression this was a duplicating process.

Erate funding is approximately 25% of QACPS's technology budget. Without access to the reimbursement of our Verizon phone bills, QACPS will lose approximately \$60,000 in technology funding for this school year. I hope you will please reconsider the previous decision made by USAC/SL as we work through our learning curve of the process and train our own staff to handle future filings.







After thorough review and investigation of all relevant facts, the Schools and Libraries Division (SLD) of the Universal Service Administrative Company (USAC) has made its decision in regard to your appeal of USAC's Funding Year 2006 Funding Commitment Decision Letter for the Application Number indicated above. This letter explains the basis of USAC's decision. The date of this letter begins the 60 day time period for appealing this decision to the Federal Communications Commission (FCC). If your Letter of Appeal included more than one Application Number, please note that you will receive a separate letter for each application.

Decision on Appeal: **Denied**
Explanation:

- During the Appeal Review, USAC thoroughly assessed the facts presented in the appeal letter, the relevant documentation on file, and the FCC Rules and Procedures before making its determination on your appeal. The applicant was asked to provide proof that the referenced Form 470 Number 333420000550950 was certified on or before the Form 471 filing date of February 16, 2006. In a fax dated May 26, 2006, the applicant provided Form 470 application number 341610000582867 as the establishing Form 470 for the application. As this was different than the original information, the Form 470 number was corrected;

however, the program violation was not corrected. For this Form 470, USAC notified you in a Receipt Notification Letter that that the earliest date on which you could sign a contract or enter into an agreement (your Allowable Contract Date) was March 14, 2006. Your Form 471 was certified on December 22, 2005. Consequently, USAC denies your appeal because your application did not comply with the competitive bidding requirement that your Form 470 be posted on the website for 28 days prior to signing a contract or entering into an agreement for new products and/or services.

- You signed and/or submitted your Form 471 prior to the expiration of the 28 day posting period. FCC Rules require that except under limited circumstances, all Forms 470 received be posted on the USAC website for 28 days, and that applicants carefully consider all bids received before selecting a vendor, entering into an agreement or signing a contract, and signing and submitting a Form 471. 47 C.F.R. secs. 54.504 (a) (c), 54.511(a) and (c). FCC Rules further require that the Administrator send the applicant a confirmation when the Form 470 has been posted, and inform the applicant of the earliest date upon which they may sign a contract with the vendor it selects. 47 C.F.R. sec. 54.504(b)(4). These competitive bidding requirements help to ensure that applicants receive the lowest pre-discount price from vendors. See Federal-State Joint Board on Universal Service, CC Docket No. 96-45, Order on Reconsideration, 12 FCC Rcd 10095, 10098, FCC 97-246 para. 9 (rel. Jul. 10, 1997).

If your appeal has been approved, but funding has been reduced or denied, you may appeal these decisions to either USAC or the FCC. For appeals that have been denied in full, partially approved, dismissed, or canceled, you may file an appeal with the FCC. You should refer to CC Docket No. 02-6 on the first page of your appeal to the FCC. Your appeal must be received or postmarked within 60 days of the date on this letter. Failure to meet this requirement will result in automatic dismissal of your appeal. If you are submitting your appeal via United States Postal Service, send to: FCC, Office of the Secretary, 445 12th Street SW, Washington, DC 20554. Further information and options for filing an appeal directly with the FCC can be found in the "Appeals Procedure" posted in the Reference Area of the SLD section of the USAC website or by contacting the Client Service Bureau. 
