**SECTION 63.71 APPLICATION OF BELLSOUTH LONG DISTANCE, INC. d/b/a
AT&T LONG DISTANCE SERVICE**

BellSouth Long Distance, Inc., d/b/a AT&T Long Distance Service ("BellSouth LD"), applies for authority under Section 214(a) of the Communications Act, as amended ("the Act"), 47 U.S.C. § 214, and Section 63.71 of the Federal Communications Commission's ("Commission") rules, 47 C.F.R. §63.71, to discontinue the following business services: BellSouth® Dial Direct Service, BellSouth® Toll Free Service, BellSouth® Long Distance Calling Card Service, BellSouth® Long Distance Voice VPN Service, BellSouth® Long Distance Domestic Private Line, BellSouth® Wavelength Service, BellSouth® Special Access Service, and BellSouth® Long Distance International Private Line Service.

As required by Section 63.71(a) and (b) of the Commission's rules, BellSouth LD is providing the following information:

Name and Address of Carrier (47 C.F.R. §§ 63.71(a)(1), (b)(2)):

Date of Planned Service Discontinuance (47 C.F.R. §§ 63.71(a)(2), (b)(2)):

BellSouth LD will no longer offer these services to new customers on or after April 27, 2007, subject to Commission authorization of the discontinuance pursuant to 47 C.F.R. § 63.71(c). BellSouth LD will continue to provide services to its existing customers until their existing contracts expire or are terminated, at which time AT&T will offer services to these customers from another AT&T affiliate.

Points of Geographic Areas of Service Affected (47 C.F.R. §§ 63.71(a)(3), b(2)):

BellSouth LD will discontinue these services throughout the continental United States and Hawaii.

Brief Description of Type of Service Affected (47 C.F.R. §§ 63.71(a)(3), b(2)):

1. Dial Direct Service allows customers to place outbound calls to terminating domestic and international locations originating in the United States via switched or dedicated origination. Customers must dial "1+" the area code or country code and the number.

2. Toll Free Service is a toll-free number service where calls may originate from any valid exchange or certain international locations and terminate to the customer's location via switched or dedicated termination.

3. Long Distance Calling Card Service is a long distance travel card that allows users to place calls from virtually any phone in the United States to any phone in the United States and any country providing International Direct Distance Dialing (IDDD).

4. Long Distance Voice VPN Service is an Advanced Intelligent Network (AIN) based voice service utilizing specialized features that optimize the carrier's network to create the appearance and functionality of a private network for the customer.

5. Long Distance Domestic Private Line Service provides customers with dedicated circuits, which connects distant locations, which cross LATA or state boundaries, on the Company's network. Service is offered on a non-switched, dedicated basis. Private Line service includes DS-0, DS-1, Fractional DS-1, DS-3, OC-3, OC-12, OC-48 and OC-192 capacity digital transmission services. These services may be used to transmit both voice and data utilizing dedicated access arrangements on both the originating and terminating ends of each circuit.

6. Wavelength Service is a point-to-point, dedicated service that utilizes dense wave division multiplexing (DWDM) technology to deliver high capacity bandwidths of 2.5-Gbps and 10-Gbps. Wavelength service differs from standard SONet Private Line products in that it is an unprotected transport facility.

7. Special Access Service (IntraLATA Long Distance Private Line Service) provides customers with a dedicated path between two or more customer premises facilities within the same LATA.

8. Long Distance International Private Line Service provides dedicated, point-to-point DS1, T1(E1), T1/E1Hybrid, DS3/E3, OC3/STM1, OC12/STM4 or OC48/STM416 transport for customers with terminating locations in the continental U.S. and other countries.

As a result of the acquisition of BellSouth Corporation and its affiliated companies by AT&T Inc., the combined entity is streamlining their business services portfolio. If this Application is approved, the services described above, currently provided by BellSouth LD, will be provided by another affiliate of AT&T.

The public convenience and necessity will not be impaired by this service discontinuance because there are many alternative providers of business services, including but not limited to AT&T Corp. Furthermore, none of the affected customers should experience a loss in service as

AT&T plans to offer a comparable suite of services to these customers through another AT&T affiliate.

Brief Description of the Dates and Methods of Notice to All Affected Customers (47 C.F.R. § 63.71(b)(3)):

BellSouth LD notified customers by letter sent via U.S. Mail on March 13, 2007. A copy of the letter is attached hereto as Attachment A.

Copies of this Application are being sent, first class U.S. Mail, to the public utilities commission and governor of each state in which discontinuance is proposed and also to the Special Assistant for Telecommunications to the Secretary of Defense, as required by 63.71(a) of the Commission's rules.

Regulatory Classification of Carrier (47 C.F.R. § 63.71(b)(4)):

BellSouth LD is considered non-dominant with respect to the services to be discontinued.


Conclusion:

As you know, AT&T Inc. acquired BellSouth Corporation late last year. As part of the integration process, the affiliated companies are streamlining their business service portfolios. As a result, the policy as it relates to contract renewals is being revised and several service offerings provided by BellSouth Long Distance, Inc. d/b/a AT&T Long Distance Service ("BellSouth LD") in the continental United States and Hawaii are being phased out.

If you are a BellSouth LD customer with one or more of the following services: BellSouth® Dial Direct Service, BellSouth® Toll Free Service, BellSouth® Long Distance Calling Card Service and/or BellSouth® Long Distance Voice VPN Service you may retain your existing service(s) and continue to conduct moves, adds and administrative changes as needed, subject to the terms of your existing BellSouth® Business Class Family of Services agreement or Customized Pricing Arrangement (collectively the "Agreement"). If you are a BellSouth LD customer with BellSouth® Long Distance Domestic Private Line, BellSouth® Wavelength Service, IntraLATA Long Distance Private Line Service, and/or BellSouth® Long Distance International Private Line Service you may retain your existing service(s) and continue to conduct moves (but not adds) and administrative changes as needed, subject to the terms of your existing Agreement.
