On average, we have listened to AM1230 for eight to ten hours a day (my wife listens to it at work). When we don't listen to AM1230, we usually listen to The Brew, 105.7 FM. We have attended station events, bought tickets and merchandise from AM1230, and patronized businesses who advertise on AM1230, as have many of our friends and acquaintances. In fact, we never listen to 610 WTVN except for Bengals games. So we have no idea who advertises on 610 WTVN. If you view the results of the recent election, the citizens of Ohio and the American people have given you, free of charge, the results of a market research study that could be worth millions of dollars to your advertisers. Ohioans voted 55% statewide progressive and in the Columbus market, 58%. This is potentially a vast untapped resource of revenues for your advertisers. It makes no business sense to ignore such a huge resource. Also, potential progressive customers generally are better educated, have higher incomes, and therefore have greater spending capacity for the products you advertise. In fact, you should really reconsider changing your Columbus station, AM610, to the progressive talk format while making AM1230 the conservative format, because AM610 has a stronger signal, therefore, it would greatly enhance your ability to reach this majority audience. How much would Clear Channel pay a marketing research company for the results that the citizens of Ohio and the United States have given you for free? It is likely that loyal listeners to Progressive AM1230 will not listen to the new format and will take their discretionary income elsewhere (XM or Sirius or Internet radio services). Cancelling progressive talk could also have a negative effect on Clear Channel's other holdings, as this majority of voters and therefore potential listeners, may switch to non-Clear Channel stations. It's sad, but it's true, in this age of satellite and Internet radio, the average consumer does not need broadcast media as much as broadcast media needs the consumer. Thank you for your consideration, and thank you for bringing progressive talk to Columbus. We have found it hugely entertaining and informative. Sincerely, Please bring the progressive format back.
