MOTION TO ACCEPT AS TIMELY FILED

SunCom Wireless, Inc. (“SunCom”) hereby files this Motion to Accept as Timely Filed with regard to its attached Petition for Reconsideration or, in the Alternative, Clarification (the “Petition”). The Petition sought reconsideration of a Public Notice released by the Wireline Competition Bureau on March 19, 2007. ^{1/} Accordingly, the Petition was due to be filed electronically on or before April 18, 2007 at 11:59 PM. SunCom repeatedly attempted this filing via ECFS, using multiple computers, over the course of several hours on the evening of April 18, but a database malfunction occurred on each attempt. ^{2/} Because of the database malfunction and SunCom’s evidence of diligence as documented in the attachments hereto, SunCom respectfully requests that the Commission accept its Petition for Reconsideration or, in the Alternative, Clarification filing as timely filed.
