



We are writing in support of Community Health Network's (CHN) application to the Federal Communications Commission's Rural Health Care Pilot Program.

As a predominately rural state, Tennessee faces many challenges in providing adequate health care. On average, end-user health centers are located 1.5 or more hours from the closest major urban center (Memphis, Knoxville, Nashville or Chattanooga), and an estimated 6-11 percent of Tennesseans do not have access to a vehicle. This program would enable Tennessee to add an additional 150 locations across the state to the existing telehealth network. The entire state will benefit from video training and continuing education courses that keep geographically-isolated health centers abreast with the latest advances in management, technology, healthcare regulation, and other areas. With expanded telehealth services, Tennessee will be able to provide more adequate patient care across the state.


delivery of health care records, and cost-effectively improving statewide health care.
