Dear Ms. Dortch:

Time Warner Telecom Inc. (“Time Warner Telecom”) hereby files this letter pursuant to Section 64.1120(e) of the Commission’s Rules to notify the Commission of the transfer of subscribers in a *pro forma* transaction as described below.

Names of the Parties to the Transaction: Xspedius Management Co. of Maryland, LLC, a wholly owned subsidiary of Time Warner Telecom, will acquire subscribers from its sister company, Xspedius Management Co. Switched Services and the company will be renamed Time Warner Telecom of Maryland LLC.

Types of Telecommunications Services Provided to Affected Customers: Xspedius Management Co. Switched Services, LLC provides local, long distance, private line and toll services in Maryland. Xspedius Management Co. of Maryland, LLC (to be known as Time Warner Telecom of Maryland LLC) will provide the same services on the same terms, rates, and conditions.

Date of the Transfer: The parties anticipate that the affected customers will be transferred to Xspedius Management Co. of Maryland, LLC (to be known as Time Warner Telecom of Maryland LLC) on or about July 1, 2007, or as soon as possible pending the receipt of regulatory approvals.

Certification of Compliance: Time Warner Telecom hereby certifies that it has provided advanced subscriber notice in accordance with Section 64.1120(e)(3) of the Commission’s rules. 47 C.F.R. § 64.1120(e)(3). Time Warner Telecom further certifies that it has complied with the obligations specified in the notice and any other applicable statutory and Commission requirements.

Copy of Notice Sent to Affected Subscribers: Attached hereto is a copy of the advance notice that was mailed to affected subscribers on June 1, 2007. If no alternative provider is selected, the subscribers will become customers of the Xspedius Management Co. of Maryland, LLC (to be known as Time Warner Telecom of Maryland LLC).

Thank you for being a loyal customer of Xspedius Management Co. Switched Services, LLC or Xspedius Management Co. of Maryland, LLC (collectively "Xspedius"). It has been our pleasure to provide you with high quality telecommunications service.

As you know, Xspedius recently sold its Maryland regulated telecommunications assets to one of the nation's leading providers of telecommunications services, Time Warner Telecom, Inc. We are pleased to now inform you that we are consolidating the Maryland regulated telecommunications assets of Xspedius and renaming the merged company "Time Warner Telecom of Maryland, LLC." Following this consolidation, Xspedius will no longer be the name of your service provider.

Your transition from Xspedius to Time Warner Telecom of Maryland, LLC for telecommunications services requires absolutely no action on your part.

The transfer of your service to the newly named company, Time Warner Telecom of Maryland, LLC will be invisible to you. There will be no change in the services you have ordered because Time Warner Telecom of Maryland, LLC will utilize the same facilities that currently serve your account. There will be no down time or modification to any of your existing services or rates. The local account team who services your account today will continue to provide you with the excellent service that you expect. Again, this corporate reorganization and transfer requires no action on your part.

As your service provider, Time Warner Telecom of Maryland, LLC will continue to provide you with the same telecommunications services you currently receive in accordance with the rates, terms and conditions of your existing contract or effective tariffs on file with the Maryland Public Service Commission. If in the future Time Warner Telecom of Maryland, LLC determines that rates, terms, or conditions require modification, it will follow your contract terms or the Maryland Public Service Commission rules regarding such changes, including, where required, written 30 day notice to customers. Xspedius and Time Warner Telecom, Inc. will continue to be responsible for the resolution of any complaints filed or otherwise raised until the consolidation is finalized.

If you do not wish to become a customer of Time Warner Telecom of Maryland, LLC, you may, in accordance with the terms of your contract, select another service provider within thirty (30) days of the date of this letter. If you do not select another provider, Time Warner Telecom of Maryland, LLC will automatically become your service provider effective thirty (30) days from the date of this letter. You will not incur any charges for the change to Time Warner Telecom of Maryland, LLC. However, should you select another provider, you may incur additional charges. If you change providers, the terms and

conditions of your Xspedius contract will still apply, including any applicable termination liability or change charges. Please be aware that you are responsible for paying all bills rendered to you by Xspedius during this transition. You may be subject to termination of your service in accordance with the terms of your contract and applicable Commission rules if you fail to pay your telephone bill.

If you do not want service from Time Warner Telecom of Maryland, LLC, you must select a new provider as soon as possible. Otherwise, you need do nothing and your service will seamlessly and automatically transfer to Time Warner Telecom of Maryland, LLC.
