Pursuant to 47 C.F.R. §63.24(e)(4), American Broadband Communications, LLC ("ABB") hereby provides this notice to inform the Commission of the consummation of the transfer of control Huntel CableVision d/b/a Huntel Communications ("Huntel"), through the change of control of ABB (Huntel's ultimate parent). The change in control arises from the redemption of Mr. William H. Tucker's membership interest in ABB, resulting in Mr. Patrick L. Eudy having 97.5% of the membership interest in ABB. The consummation occurred on June 11, 2007. Huntel's international Section 214 authority was granted under File No. ITC-214-200001025-00632. The transfer of control of Huntel was approved under File No. ITC-T/C-20070518-00198.

ABB also notes that the domestic transfer of control application involving Huntel and affiliated companies as noted in WC Docket No. 07-93 was also consummated on June 11, 2007.
