Out of an abundance of caution, Sangre de Cristo Communications, Inc. ("SCC"), licensee of KOAA(TV), Pueblo, Colorado, reiterates its proposal to conform the allotment for KOAA-DT with the actually constructed facilities. SCC understands that the Commission has received an extraordinary number of requests in connection with the Seventh Further Notice of Proposed Rulemaking in the above-referenced proceeding ("*FNPRM*"),<sup>1</sup> and we wish to ensure that the Commission is fully aware of our belief that our proposal meets the standards for modifications of allotments. 
