On June 22, 2007, the Commission forwarded a copy of Information and Document Request for Liberty ("Request") to Craig Troyer, Assistant General Counsel of Discovery Holding Company ("Discovery Holding"). 
which are confidential and proprietary. Discovery Holding has reviewed the documents carefully in determining whether they should be classified as publicly available or confidential.

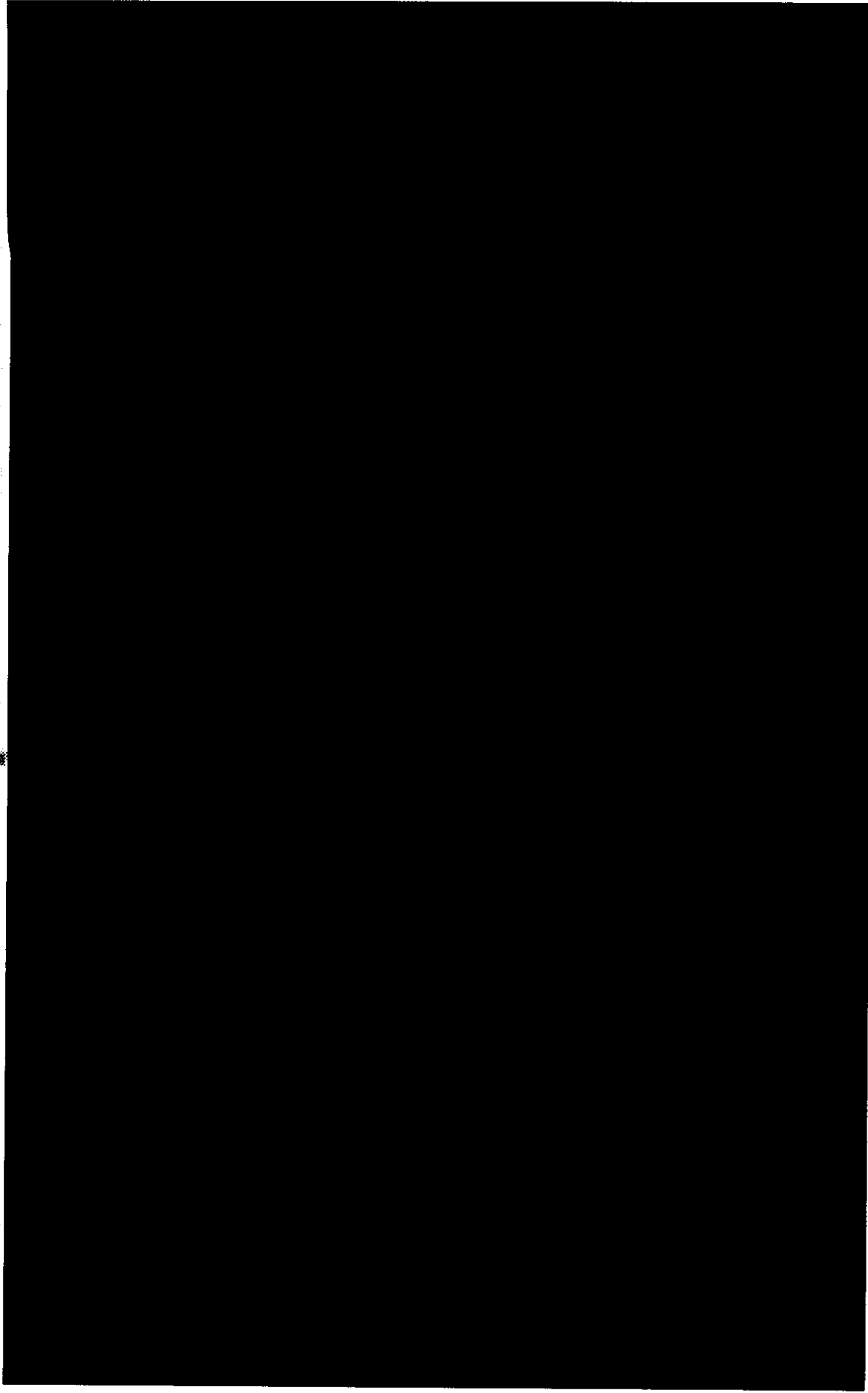

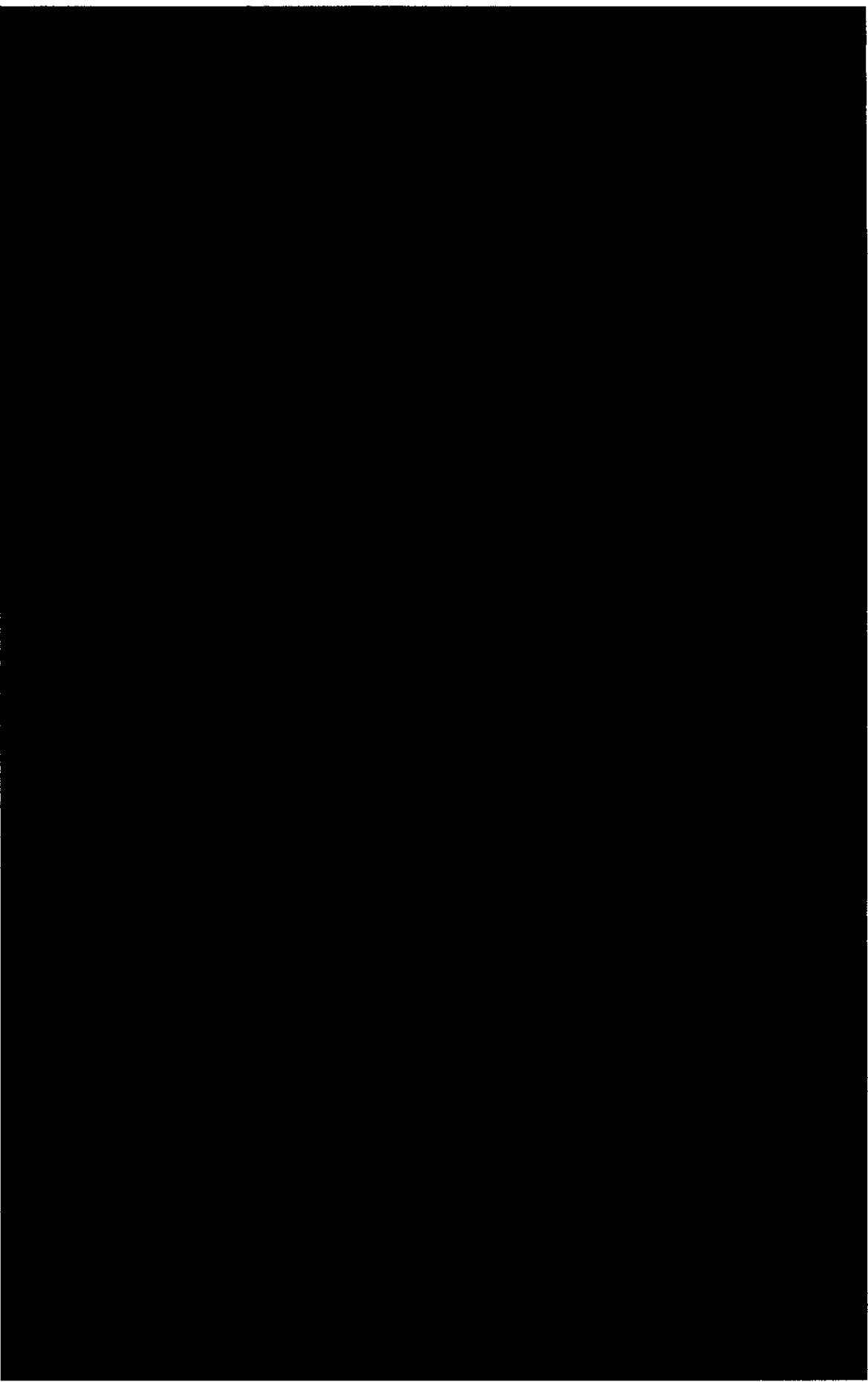

Sum of the parts schedule

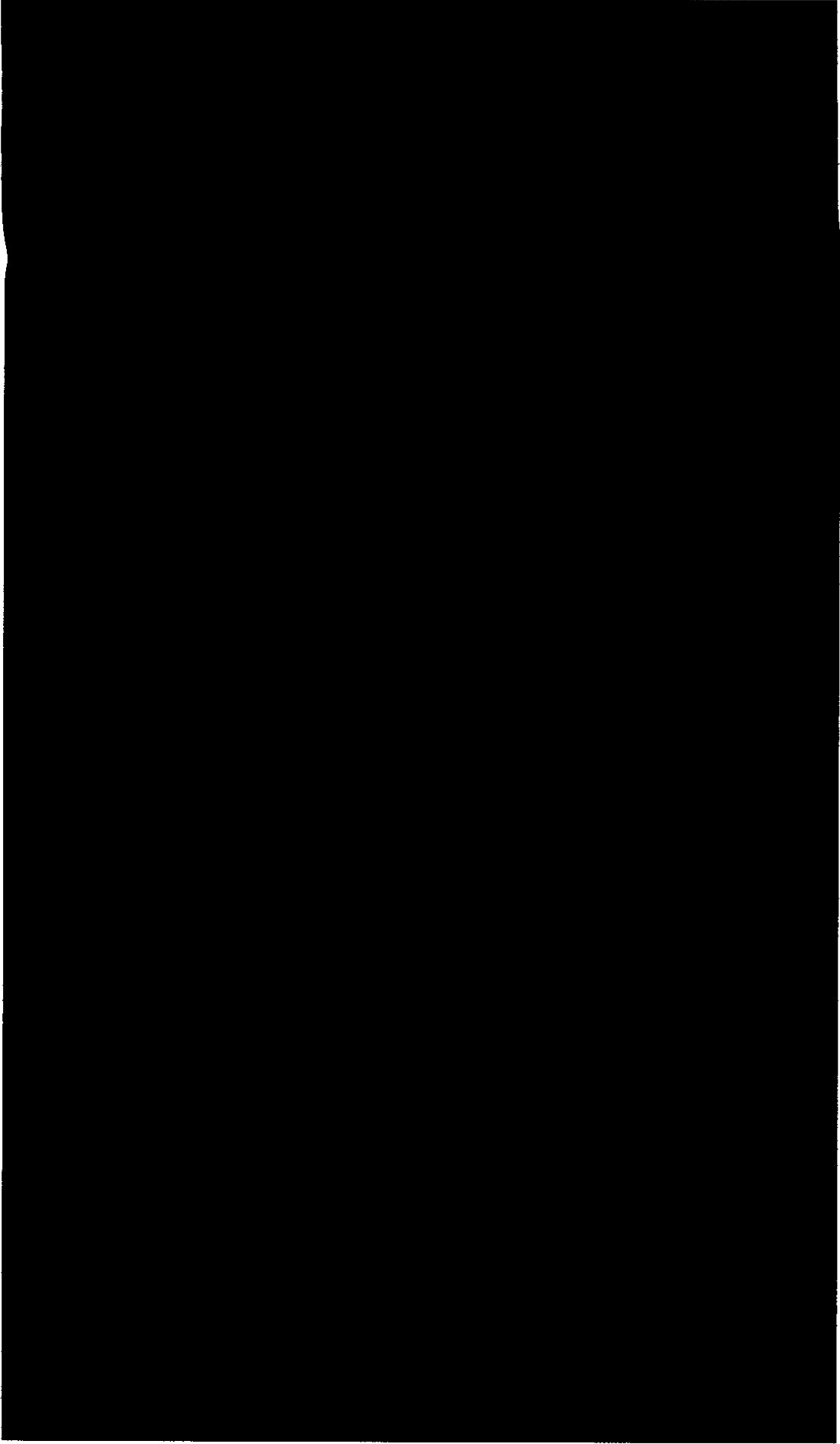


Sum of the parts schedule

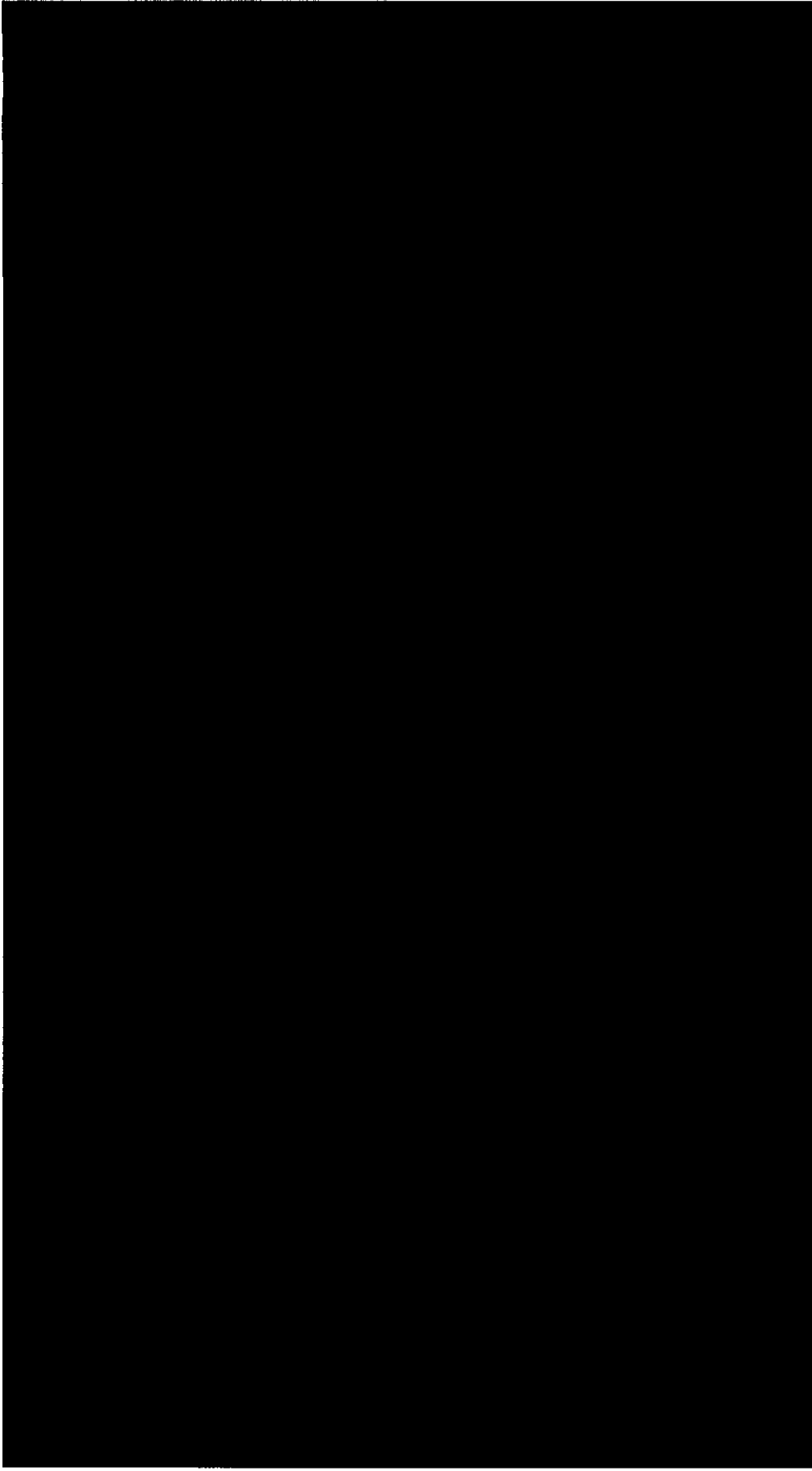

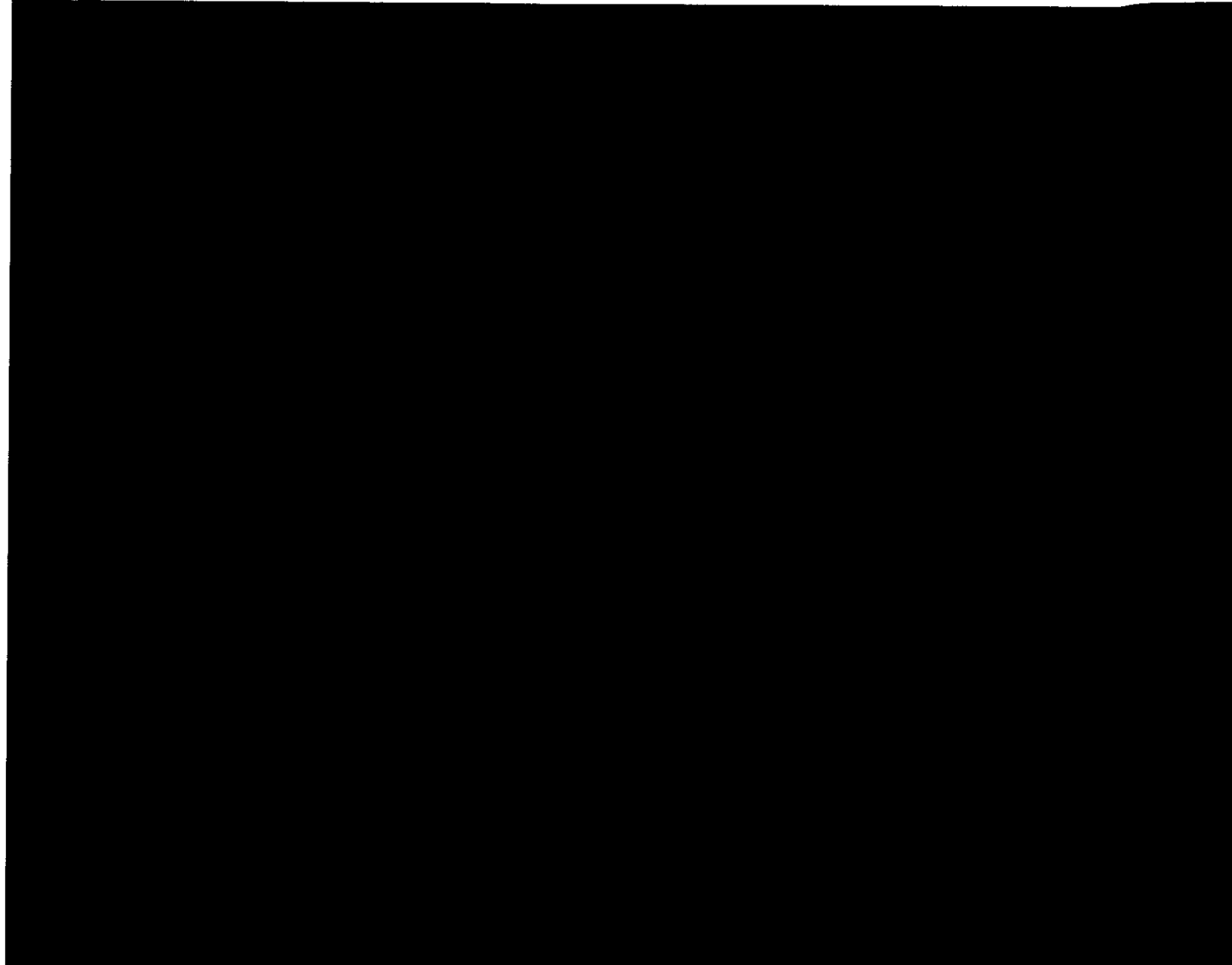
DHC SOP 3/31/2008
