On behalf of Enterprise Wireless Alliance ("EWA") and Utilities Telecom Council ("UTC"), and in accordance with Section 1.1206(b) of the Commission's Rules, 47 C.F.R. § 1.1206(b), undersigned counsel hereby submits the instant notice of an *ex parte* presentation.

On July 17, 2007, Mark Crosby, President and CEO of EWA; Jill Lyon, Vice President and General Counsel of UTC; and undersigned counsel representing EWA, met with the following representatives of the Office of Engineering and Technology: Julius Knapp, Chief; Ron Repasi, Acting Deputy Chief; Bruce Romano, Associate Chief (Legal); Ira Keltz, Chief, Electromagnetic Compatibility Division; Jamison Prime, Spectrum Policy Branch Chief, Policy and Rules Division; Joe Dichoso, Equipment Authorization Branch Chief, Laboratory Division; and Jim Szeliga, Telecommunications Systems Specialist, Laboratory Division.

The topics of the meetings were EWA's and UTC's filings in WT Docket Nos. 05-62 (900 MHz) and 99-87 (6.25 kHz) and ET Docket Nos. 04-151 (3 GHz) and 04-186 (UHF TV).

UTC also discussed the Nuclear Energy Institute ("NEI") and United Telecom Council Request for Waiver to Permit The Use of Certified Wireless Headsets and Intercom Devices at Nuclear Facilities (ET Docket No. 05-345). In particular, the discussion pertained to issues raised in early processing of applications for experimental licenses at NTIA, under an MOU between NEI/UTC and broadcast associations.
