The "Supplement to Petition for Reconsideration" is being simultaneously filed herewith. In support whereof, the following is shown:

1. It is submitted that the public interest, convenience and necessity would be served by consideration of the Supplement, which reports new facts affecting the rulemaking proposal stated in this docket. On Monday of this week, July 9, 2007, Shawsville, Virginia Channel 273A applicants George S. Flinn, Jr. (File No. BP-19971022MC) and Grace Communications, L. C. (File No. BP-19971023ME) filed

separate amendments to their respective applications to relocate their transmitter sites to a point which is fully-spaced with WOLD-FM, Marion, Virginia, assuming that the latter station regains its licensed status on Channel 273A.

2. There are no parties who have expressed an opposition to the proposal set forth by JBL, and consideration of the Flinn and Grace amendments now allows the Commission to be in a position to immediately grant JBL's petition and make the changes to the FM Table of Allotments.
