Time Warner Telecom Inc. ("Time Warner Telecom") hereby files this letter pursuant to Section 64.1120(e) of the Commission's Rules to notify the Commission of the transfer of subscribers in a *pro forma* transaction as described below.

*Names of the Parties to the Transaction:* Time Warner Telecom of Colorado LLC, a wholly owned subsidiary of Time Warner Telecom, will acquire subscribers from its sister company, Xspedius Management Co. Switched Services, LLC and Xspedius Management Co. of Colorado Springs, LLC ("Xspedius affiliates").

*Types of Telecommunications Services Provided to Affected Customers:* Xspedius affiliates provide local, long distance, private line and toll services in Colorado. Time Warner Telecom of Colorado LLC will provide the same services on the same terms, rates, and conditions.

*Date of the Transfer:* The parties anticipate that the affected customers will be transferred to Time Warner Telecom of Colorado LLC on or about August 5, 2007, or as soon as possible pending the receipt of regulatory approvals.

*Certification of Compliance:* Time Warner Telecom hereby certifies that it has provided advanced subscriber notice in accordance with Section 64.1120(e)(3) of the Commission's rules. 47 C.F.R. § 64.1120(e)(3). Time Warner Telecom further certifies that it has complied with the obligations specified in the notice and any other applicable statutory and Commission requirements.

*Copy of Notice Sent to Affected Subscribers:* Attached hereto is a copy of the advance notice that was mailed to affected subscribers on July 6, 2007. If no alternative provider is selected, the subscribers will become customers of Time Warner Telecom of Colorado LLC.

**AN IMPORTANT NOTICE REGARDING YOUR  
TELECOMMUNICATION SERVICE FROM

On June 25, 2007 Time Warner Telecom of Colorado LLC , Xspedius Management Co. Switched Services, LLC and Xspedius Management Co. of Colorado Springs, LLC (jointly "Xspedius") filed an application with the Colorado Public Utilities Commission (PUC) for a transfer of its Colorado regulated telecommunications assets to Time Warner Telecom of Colorado LLC. Following this transfer of assets, Xspedius will no longer provide telecommunications services in Colorado. The transition from Xspedius to Time Warner Telecom of Colorado LLC for telecommunications services requires no action on your part and will be at no charge to you as long as you remain with Time Warner Telecom of Colorado LLC as your provider.

If you wish to retain your current services, which will be provided by Time Warner Telecom of Colorado LLC upon the effective date of the transfer, you do not need to do anything. As your new service provider, Time Warner Telecom of Colorado LLC will continue to provide you with the same telecommunications services you currently receive in accordance with the rates, terms and conditions of your existing service.

However, if you do not wish to continue your current service with Time Warner Telecom of Colorado LLC, you must select another service provider within thirty (30) days of the date of this letter. Should you select another provider, you may incur additional charges from that provider to establish service. Any existing carrier freeze(s) will be lifted to execute the transfer to another provider and it will be up to you to ask the new provider to institute a freeze after the transfer. Please be aware that you are responsible for paying all bills rendered to you by Xspedius during this transition.

If you do not select another provider Time Warner Telecom of Colorado LLC will automatically become your service provider upon the effective date of the transfer even if you have any authorized freeze(s) in place.
