Dear Ms. Dortch:

Time Warner Telecom Inc. (“Time Warner Telecom”) hereby files this letter pursuant to Section 64.1120(e) of the Commission’s Rules to notify the Commission of the transfer of subscribers in a *pro forma* transaction as described below.

Names of the Parties to the Transaction: Time Warner Telecom of Texas, L.P., a wholly owned subsidiary of Time Warner Telecom, will acquire subscribers from its sister company, Xspedius Management Co. Switched Services, LLC and Xspedius Management Co. of Jacksonville, LLC (“Xspedius affiliates”) and the company will be renamed Time Warner Telecom of Texas LLC.

Types of Telecommunications Services Provided to Affected Customers: Xspedius affiliates provide local, long distance, private line and toll services in Texas. Time Warner Telecom of Texas, L.P. (to be renamed Time Warner Telecom of Texas LLC) will provide the same services on the same terms, rates, and conditions.

Date of the Transfer: The parties anticipate that the affected customers will be transferred to Time Warner Telecom of Texas, L.P. (to be renamed Time Warner Telecom of Texas LLC) on or about August 23, 2007, or as soon as possible pending the receipt of regulatory approvals.

Certification of Compliance: Time Warner Telecom hereby certifies that it has provided advanced subscriber notice in accordance with Section 64.1120(e)(3) of the Commission’s rules. 47 C.F.R. § 64.1120(e)(3). Time Warner Telecom further certifies that it has complied with the obligations specified in the notice and any other applicable statutory and Commission requirements.

Copy of Notice Sent to Affected Subscribers: Attached hereto is a copy of the advance notice that was mailed to affected subscribers on July 24, 2007. If no alternative provider is selected, the subscribers will become customers of Time Warner Telecom of Texas, L.P. (to be renamed Time Warner Telecom of Texas LLC).

**AN IMPORTANT NOTICE REGARDING YOUR

Thank you for being a loyal customer of Xspedius Management Co. Switched Services, LLC (“Xspedius”). It has been our pleasure to provide you with quality telecommunications service.

As you know, Xspedius recently sold its Texas regulated telecommunications assets to Time Warner Telecom Inc. We are pleased to now inform you that Time Warner Telecom Inc. is consolidating all of its Texas regulated telecommunications assets into Time Warner Telecom of Texas, L.P., and changing its name to “Time Warner Telecom of Texas LLC”, a subsidiary of Time Warner Telecom Inc. Following this consolidation, Xspedius will no longer provide telecommunications services in Texas. Your transition from Xspedius to Time Warner Telecom of Texas LLC for telecommunications services requires no action on your part.

The transfer of your service to Time Warner Telecom of Texas LLC will be invisible to you because Time Warner Telecom of Texas LLC will utilize the same facilities that currently serve your account. Moreover, there will be no change in the services you have ordered. The transfer of your services to Time Warner Telecom of Texas LLC will be seamless and without down time or modification to existing services or rates. The local account team who services your account today will continue to provide you the excellent service that you have experienced to date.

The vision, financial capital, and experience of Time Warner Telecom Inc. will bring our customers innovation and excellent customer service. As your new service provider, Time Warner Telecom of Texas LLC will continue to provide you with the same telecommunications services you currently receive in accordance with the rates, terms and conditions of your existing contract or effective tariffs on file with the Texas Public Utility Commission. If in the future Time Warner Telecom of Texas LLC determines that rates, terms, or conditions require modification, it will follow the contract terms or the Texas Public Utility Commission rules regarding such changes, including, where required, written 30 day notice to customers. Xspedius and Time Warner Telecom Inc. will continue to be responsible for the resolution of any complaints filed or otherwise raised until the consolidation is finalized.

If you do not wish to become a customer of Time Warner Telecom of Texas LLC you may, in accordance with the terms of your contract, select another service provider within thirty days of the date of this letter. If you do not select another provider Time Warner Telecom of Texas LLC will automatically become your service provider effective thirty days from the date of this letter. You will not incur any charges for the change to Time Warner Telecom of Texas LLC. However, should you select another provider, you may incur additional charges. If you change providers, the terms and conditions of your Xspedius contract will still apply, including any applicable termination liability or change charges. Please be aware

that you are responsible for paying all bills rendered to you by Xspedius during this transition. You may be subject to termination of your service in accordance with the terms of your contract and applicable Commission rules if you fail to pay your telephone bill.

If you do not want service from Time Warner Telecom of Texas LLC you must select a new provider as soon as possible. Otherwise, you need do nothing and your service will seamlessly transfer to Time Warner Telecom of Texas LLC.
