Iridium Satellite LLC ("Iridium"), by its counsel, hereby requests that the Commission direct the applicants and/or related parties in the above-captioned proceeding to file with the Commission and to make available to interested parties (under the Protective Order¹ adopted in this proceeding, if necessary) additional materials referenced in the documents the parties have submitted thus far. Specifically, Iridium requests that the applicants and/or related parties be directed to file [REDACTED].

In its Opposition to Petitions to Deny, CIP Canada Investment Inc. ("CIP") attached in redacted form two agreements relating to the proposed transaction – a Loan Facility Agreement between CIP UK Holdings Limited, CIP, and Inmarsat Finance III Limited ("Inmarsat") and a Call Option Agreement between Communications Investment Partners Limited and Inmarsat. In its Protective Order in this proceeding, the Commission granted interested parties access to the unredacted versions of these documents. The confidential portions of the Loan Facility Agreement refer repeatedly to [REDACTED], a document that the parties have not provided to the Commission or made available to interested parties. The nature of the relationship among the applicants, CIP and Inmarsat post-transaction is a central issue to the Commission's review of the proposed transaction as well as a key concern raised in the petitions to deny and other comments in this proceeding. [REDACTED] so prominently and repeatedly referenced in the Loan Facility Agreement should shed light on this issue – [REDACTED].

For these reasons, Iridium, by its counsel, requests that the Commission direct the applicants and/or related parties to file with the Commission and to make available to interested parties the [REDACTED]. If warranted, such document can be submitted on a confidential basis and made available to interested parties under the terms of the Protective Order adopted in this proceeding.
