**REQUESTS BY BRAZOS TELEPHONE COOPERATIVE, INC.; CAP ROCK TELEPHONE COOPERATIVE, INC.; CUMBY TELEPHONE COOPERATIVE, INC.; FIVE AREA TELEPHONE COOPERATIVE, INC.; NORTH CENTRAL TELEPHONE COOPERATIVE, INC.; AND WES-TEX TELEPHONE COOPERATIVE, INC. FOR AUTHORITY TO INCLUDE IN THEIR RATE BASES THE INTERSTATE PORTION OF PREPAID POST-RETIREMENT HEALTH BENEFITS**

Six rate-of-return incumbent local exchange carriers separately filed letters requesting authority to include in their rate bases the interstate portion of the prepaid post-retirement health benefits recorded in Account 1410, Other noncurrent assets.<sup>1</sup> The carriers -- Brazos Telephone Cooperative, Inc., Cap Rock Telephone Cooperative, Inc., Cumby Telephone Cooperative, Inc., Five Area Telephone Cooperative, Inc., North Central Telephone Cooperative, Inc., and Wes-Tex Telephone Cooperative, Inc. -- each use a pre-funded trust for these retirement benefits, and the trusts have various pre-paid balances relating to post-retirement health benefits as of December 31, 2006.<sup>2</sup>

Interested parties may file comments on or before **August 8, 2007**, and reply comments on or before **August 20, 2007**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>3</sup> Comments filed through the ECFS can be sent as an electronic file via the Internet to <http://www.fcc.gov/cgb/ecfs/>. Generally, only one copy of an electronic submission must be filed.<sup>4</sup> In completing the transmittal screen, commenters should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number, in this case **WC Docket No. 07-150**. Parties may also submit an electronic comment by Internet e-mail. To get filing instructions for e-mail comments, commenters should send an e-mail to [ecfs@fcc.gov](mailto:ecfs@fcc.gov), and should include the following words in the body of the message, "get form <your e-mail address>." A sample form and directions will be sent in reply. Parties who choose to file by paper must file an original and four copies of each filing. Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail (although we continue to experience delays in receiving U.S. Postal Service mail). **Parties are strongly encouraged to file comments electronically using the Commission's ECFS.**

This matter shall be treated as a “permit-but-disclose” proceeding in accordance with the Commission’s *ex parte* rules.<sup>5</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one- or two-sentence description of the views and arguments presented generally is required.<sup>6</sup> Other requirements pertaining to oral and written *ex parte* presentations are set forth in section 1.1206(b) of the Commission’s rules.<sup>7</sup>
