Re: *Consolidated Application of News Corporation, The DIRECTV Group, Inc., and Liberty Media Corporation for Authority to Transfer Control (MB Docket No. 07-18)*

Dear Ms. Dortch:

On August 3, 2007, the DIRECTV Group, Inc. ("DIRECTV") submitted certain documents in response to the Initial Information and Document Requests issued to it on June 15, 2007. On August 14, 2007, DIRECTV resubmitted certain documents in order to address Commission concerns regarding redaction. Those documents contained unique Bates numbers – that is, the Bates numbers in the resubmission did not correspond to the Bates numbers in the original submission.

DIRECTV is today producing a new version of those resubmitted documents. Each document now contains a Bates number that corresponds to the Bates number of the August 3 submission, with the added suffix "R" (for "re-filed"). That is, each page of this filing should match the corresponding page of the August 3 filing. Furthermore, the August 14 filing contained a single page that was missing from the August 3 filing, most likely due to a copying error. That page is included in this filing. We have placed that page, which we believe contains an entire document, at the end of the production responsive to Request II.G. Accordingly, the page's Bates number is DTV-II.G-004679a(R). The letter "a" has been added to denote that it is an additional page.

Please note that each of these corrected documents remains Highly Confidential, and thus should *not* be placed in the public record of this proceeding. Accordingly, one copy of the Highly Confidential filing is being submitted under separate cover to the Secretary, and two copies to William Beckwith.
