



Dear Ms. Dortch,

Galveston Independent School District (here after called GISD) respectfully requests an appeal/waiver to certain FCC Rules requiring a signed agreement or Letter of Agency (LOA) for consultants utilized by an eligible entity, as determined by the USAC.

GISD received a letter from USAC dated April 26, 2007, denying GISD's appeal of USAC's funding commitment decision letter dated August 15, 2006. In this letter, USAC denied GISD's request for E-Rate funding of \$417,281.47 for the year 2006 based upon the determination that GISD violated competitive bidding requirements of the FCC. USAC perceived there to be a failure on the part of GISD to have a signed consulting agreement in place for the 2006 E-Rate year. (See Exhibit "A" attached) The USAC states in its denial letter that "The Origin Group" acted as a consultant without signing an agreement. Its decision further indicates that "FCC Rules require that FCC Forms 470 and 471 be signed by a person authorized to order telecommunications and other supported services for eligible entities and to certify under oath to all the required certifications." Consequently, the funding requests were denied for violation of the competitive bidding requirements."

GISD believes that USAC has misinterpreted FCC Rules by requiring that any consultant that provides "advice" to an eligible entity is required to have a signed LOA, when that consultant does not sign, authorize, or certify FCC Forms 470 and 471 and does not assist the applicant in any manner with the competitive bidding requirement process.

FCC rules regarding "Consultant Letter of Agency" as documented on the USAC web site are as follows:

"A consultant or anyone signing as the authorized person who is not a school or library employee should also have an LOA from the applicant expressly authorizing the consultant to represent the applicant." (See Exhibit B-1 attached hereto)

Furthermore, the "Sample Letter of Agency (LOA)" news release provided to applicants by the USAC on 2/1/05 (See Exhibit B-2 attached hereto) states:

"A Letter of Agency demonstrates the authorization of the person (on FCC forms, the "Authorized Person") to sign an FCC form on behalf of one or more eligible schools and/or libraries. Generally, two situations require an LOA or similar authorizing document:

. . . (2) A consultant -- or anyone signing as the authorized person who is not a school or library employee-- should have an LOA from the applicant expressly authorizing the consultant to represent the applicant."

GISD did not agree that a consultant agreement or LOA is required when the consultant is not the authorized person to order telecommunications and other supported services for the eligible entity and to certify under oath to all the required certifications. Additionally, the consultant utilized in an advisory capacity by GISD (The Origin Group) was not authorized to sign, authorize, or certify FCC forms 470 and 471 on behalf of GISD and, in fact, did not sign, authorize, or certify FCC forms 470 and 471 on behalf of GISD during the E-Rate 2006 cycle.

1. GISD's application 470 number 19194000561722 and Form 471 application number 495787 for funding year 2006, was prepared, reviewed and signed by Nunzio Arcidiacono, a GISD employee, who served as Director of Purchasing for the District. (See Exhibit C attached hereto indicating Mr. Arcidiacono's employment status, Exhibit D attached hereto of the certification pages for Forms 470 and 471 for funding year 2006, signed and certified by Mr. Arcidiacono.)
2. Chris Webber, a GISD employee, who served as Director of MIS, was named as the contact person in the aforementioned 470 and 471. (See Exhibit "E" attached indicating Mr. Webber's employment status with GISD and attesting to the fact that Christopher C Webber, GISD's employee, is not Christopher R Webber, a consultant out of the state of Oklahoma).
3. Both Mr. Arcidiacono and Mr. Webber, as GISD employees, acting in their respective positions with the district, were authorized to order telecommunications and other supported services for GISD and were authorized to certify under oath to all the FCC required certifications.
4. In correspondence sent to USAC on 5/23, in response to USAC's question as followup to SR-2006-141339, regarding GISD's use of a consultant. (See Exhibit F hereto attached), GISD states that the Origin Group provided the following services for E-Rate funding year 2006:
 - a. provided recommendations to GISD for eligible services.
 - b. assisted GISD in preparing information necessary to complete Forms 470..
 - c. assisted GISD in preparing information and required documentation for completion Forms 471
5. The Origin group never took any official action related to E-Rate on behalf of GISD.

Furthermore, FCC rules, as detailed on the USAC website regarding the Competitive Bidding Process, state:

"The competitive bidding process must be fair and open. "Fair" means that all bidders are treated the same and that no bidder has advance knowledge of the project information. "Open" means there are no secrets in the process. . . The Form 470 should be clear about the products, services, and quantities the applicant is seeking. . .

The rule goes on to further say . . . a conflict of interest exists when the applicant's consultant is associated with a service provider that is selected and is involved in determining the services sought by the applicant and the selection of the applicant's service providers." (See Exhibit G attached hereto)

Thus, GISD asserts the following:

1. GISD followed all FCC and State competitive bidding requirements in the filing of its requests for E-rate services for 2006. At no time did the Origin Group assist GISD in the competitive bidding process (See Exhibit H, portion related to competitive bidding of SR-2006-141339, GISD response submitted May 19, 2006 attached hereto)
2. Origin Group was never authorized to represent GISD in any of the competitive bidding transactions or in any other matter relating to E-Rate applications.
3. Origin Group does not represent a service provider and is not a service provider and, therefore, does not create a conflict of interest in determining the services sought by the applicant and the selection of the applicant service providers. (See Exhibit I, letter from the Origin Group dated June 21, 2007, attached hereto)

SUMMARY: GISD'S REQUEST FOR APPEAL/WAIVER

- (1) It is the position of GISD that FCC rules are ambiguous as to the requirement to have a Letter of Agency in an instance where the consultant plays only a ministerial role in the E-Rate application process.
- (2) USAC's actions were confusing in not asking specific questions with respect to the exact role the Origin Group played in GISD's 2006 E-Rate application. During the SR-2006-141339 and followup phase, USAC did not ask if Origin Group was the signer of our application or was a service provider.
- (3) GISD acknowledges that we did not have a signed agreement with the Origin Group for 2006 E-Rate year. GISD further asserts that a signed agreement is not necessary. GISD also asserts that the Origin Group only acted as an advisor and did not represent us in any official capacity.
- (4) Additionally, the Origin Group is not a service provider and does not provide E-Rate eligible services. Thus, GISD asserts that competitive bidding requirements were not violated and there was no attempt to defraud the government.
- (5) USAC's documentation never specifically refers to an LOA being required when a consultant simply serves in an advisory capacity to an applicant. GISD further points out that State E-Rate Coordinators function also in an advisory capacity to applicants.

In the event GISD has been mistaken in its interpretation of the requirement for an LOA in all instances, then GISD respectfully requests the FCC to waive this LOA requirement, as it pertains to GISD's application for 2006 E-Rate funding.



After thorough review and investigation of all relevant facts, the Schools and Libraries Division (SLD) of the Universal Service Administrative Company (USAC) has made its decision in regard to your appeal of USAC's Funding Year 2006 Funding Commitment Decision Letter for the Application Number indicated above. This letter explains the basis of USAC's decision. The date of this letter begins the 60 day time period for appealing this decision to the Federal Communications Commission (FCC). If your Letter of Appeal included more than one Application Number, please note that you will receive a separate letter for each application.

Decision on Appeal: **Denied**
Explanation:

- After thorough review of the appeal and the relevant facts and documentation, it was determined that a consultant was used for the preparation of the Forms 470 and completion of the Forms 471, but Galveston Independent School District failed to provide a consultant agreement or Letter of Agency. On May 19, 2006, the District submitted documentation which stated the District did not have a signed consultant agreement or Letter of Agency. The Reviewer sent additional follow up questions on May 23, 2006, asking the District to submit a signed copy of the consulting agreement and list the services rendered by the consultant. In response to the request for further clarification, the District stated that the consultant assisted with the completion of the Forms 470 and Forms 471.

According to documentation submitted to USAC, The Origin Group acted as a consultant without signing an agreement with the District. Consequently, the funding requests were denied for violation of the competitive bidding requirements. On appeal you submitted a copy of a consulting agreement between Galveston School District and The Origin Group. Program rules do not permit USAC to accept new information on appeal except where an applicant was not given an opportunity to provide information during the initial review or an error was made by USAC. Therefore, the appeal is denied.

- FCC Rules require that FCC Forms 470 and 471 be signed by a person authorized to order telecommunications and other supported services for the eligible entities and certify under oath to all the required certifications. 47 C.F.R. secs. 54.504(b)(2), 54.504(c)(1). The authorized person certifies on the Form 470 and Form 471 that he or she is the person authorized to submit and certify to the accuracy of the applications. See Schools and Libraries Universal Service, Description of Services Requested and Certification Form 470, OMB 3060-0806, Block 5 and Schools and Libraries Universal Service, Services Ordered and Certification Form 471, OMB 3060-0806, Block 6. Consultants or other signers who are not employees of the Billed Entity must have a Letter of Agency from the applicant affirming that they are authorized to represent the applicant. See Instructions for Completing the Schools and Libraries Universal Service Services Ordered and Certification Form (FCC Form 471), OMB 3060-0806 and the Reference Area at our website, www.usac.org/sl. Additionally, the FCC has stated that, if consultants are involved, beneficiaries must retain signed copies of all written agreements with E-rate consultants. See Schools and Libraries Universal Service Support Mechanism, CC Docket No. 02-6, Fifth Report and Order and Order, 19 FCC Red 15808, 15824-26, FCC 04-190 para. 48 (rel. Aug. 13, 2004).

If your appeal has been approved, but funding has been reduced or denied, you may appeal these decisions to either USAC or the FCC. For appeals that have been denied in full, partially approved, dismissed, or canceled, you may file an appeal with the FCC. You should refer to CC Docket No. 02-6 on the first page of your appeal to the FCC. Your appeal must be received or postmarked within 60 days of the date on this letter. Failure to meet this requirement will result in automatic dismissal of your appeal. If you are submitting your appeal via United States Postal Service, send to: FCC, Office of the Secretary, 445 12th Street SW, Washington, DC 20554. Further information and options for filing an appeal directly with the FCC can be found in the "Appeals Procedure" posted in the Reference Area of the SLD section of the USAC website or by contacting the Client Service Bureau. We strongly recommend that you use the electronic filing options.

Letter of Agency

The authorized person on the Form 471 - the person whose signature appears in the Form 471 Item 38 - certifies that he or she is the person authorized to submit and certify to the accuracy of the application. This person must be authorized to represent any and all of the entities for which discounts are sought in the funding requests featured on the application. During its review of the Form 471, USAC may require copies of the documentation that confirms this person's authorization to represent all of the entities featured on the Form 471.

The evidence that establishes this authorization - and therefore, that establishes the relationship between the authorized person and the entities featured on the form - is generally a Letter of Agency (LOA).

Consortium Letter of Agency

A Letter of Agency (LOA) is most commonly signed by consortium members and kept on file by their consortium leader to verify their knowledge of their membership and participation in the consortium. Other vehicles to establish this authorization could be a project agreement, a contract, a letter agreement, or other similar document. The consortium LOA must be signed and dated on or before the postmark date of the Form 471 certification or the date the form was certified online.

Consultant Letter of Agency

A consultant or anyone signing as the authorized person who is not a school or library employee should also have an LOA from the applicant expressly authorizing the consultant to represent the applicant. The consultant LOA must be signed and dated before the first action is taken by that Consultant on your behalf (such as filing the Form 470).

Whatever the form of the document establishing the above authorization, it must contain all of the following:

- The name of the person filing the application (the consortium leader or consultant)
- The name of the person authorizing the filing of the application (the entity who will receive discounted services, such as a consortium member)
- The specific timeframe the LOA or authorizing document covers (for example, the E-Rate Funding Year 2003)
- The signature, signature date, and title of an official who is an employee of the entity who is authorizing the filing of the application (the entity who will receive discounted services, such as a consortium member)
- The type of services covered by the LOA or authorizing document. The description of services can be as general as "all E-Rate eligible services" or it can be more restrictive (e.g., "basic telephone service only").

NOTE: The timeframes of these authorizations cannot be open-ended, such as "until terminated by either party."

In certain situations, other documentation may be accepted as proof of authorization. For example, for consortium applications, the consortium lead member must either collect LOAs from each consortium member or be able to provide some other proof that each consortium member knew it was represented on the application. Consortia which have a statutory or regulatory basis and for which participation by schools or libraries is mandatory must be able to provide documentation supporting this certification, including copies of the relevant state statute or regulation.

Note: If the LOA authorizes a *consortium leader* to apply for discounted services on your behalf, then it must be signed and dated on or before the postmark date of the Form 471 certification or the date the form was certified online. If the LOA authorizes a *consultant* to act on your behalf, then it must be signed and dated before the first action is taken by that consultant on your behalf (such as filing the Form 470).

SLD Provides Clarification for Eligibility of Priority 1 Services (2/15/05)

The SLD has recently seen marketing efforts regarding video and other services in the Telecommunications and Internet Access categories that misconstrue FCC eligibility requirements.

In the Telecommunications category of service, the FCC's Eligible Services List indicates, in the listing for "Distance Learning Circuits," that "[t]ransmission services that provide [video or other] distance learning are eligible for discount." Some may have mistakenly concluded that this statement indicates that any Distance Learning service is eligible, when in fact the statement is limited to eligibility for the transmission services that enable distance learning.

Since a full distance learning system may include components beyond the FCC's definition of a telecommunications service, applicants must use care that the costs of ineligible features have been removed when submitting funding requests.

In the Internet Access category of service, the FCC's Eligible Services List indicates that the Internet Access category of service is "limited to the provision of 'basic conduit access' to the Internet." Some may have mistakenly concluded that Internet Access can include functions that go beyond "basic conduit access" to the Internet, such as a direct exchange of data or video between applicant sites. Such conclusions are incorrect. In the Internet Access category of service, the SLD will only fund services that are within FCC requirements for "basic conduit access" to the Internet. Funding in this category will not be provided for transport of point-to-point connectivity of data, video, or voice applications that are to be provided only by eligible telecommunications carriers.

Applicants are cautioned that funding requests for products and services that are ineligible should not be submitted. Any funding requests that include a combination of eligible and

ineligible components must be cost-allocated to remove ineligible features.

Invoice Improvement Update: Billing/Shipping Date Review (2/14/05) Top of Page

SLD has initiated an evaluation of the invoice review process. The goal of this evaluation is to speed up the processing of invoices without compromising program integrity. As SLD implements improvements to the invoice review process, notice will be posted to this web site with "Invoice Improvement Update" in the title. This is the first of these postings.

In the past, if the date for customer billing or shipping reported on a line in Column 11 or Column 12 on an FCC Form 474 (SPI Form) was

- before the start of the funding year,
- before the service start date reported on the Form 486, or
- after the close of the funding year and the last allowable date to invoice,

the Invoice reviewer was required to contact the service provider, work through the discrepancy, and then verify receipt of the necessary documentation that supported compliance with program rules.

Under a recently-enacted change to the review process, if the billing or shipping date in a line item on a SPI Form does not comply with program rules, that line item will be denied.

A line item denied for this reason will be featured on a remittance statement with the appropriate invoice error code. This line item may be submitted on a new SPI Form with the correct date.

SPIN Support for Online Filers (2/14/05) Top of Page

If you are still filing your Form 471, and are filing online, you must have a Service Provider Identification Number (SPIN) for each Funding Request in order to progress through Block 5 of the online form. Filers who do not have a SPIN will receive a message as they attempt to complete the form directing them to call the Client Service Bureau (CSB) for assistance.

Please note that SPIN assistance is available for those online filers who have completed the competitive bidding process and selected their service providers, but whose service providers' SPIN assignment has not yet been completed. (Manual filers are able to provide either the service provider name or the SPIN in order to meeting Minimum Processing Standards.) The Item 21 attachment should clearly indicate the name of the service provider. Call the CSB toll-free at 1-888-203-8100, and representatives will provide you this assistance. Remember that the CSB hours of service are 8:00 a.m. to 8:00 p.m. EST.

SLD Posts Improved Online Form 474 (2/7/05) Top of Page

SLD has posted an improved online Form 474. The information required on the form is the same as the previous version; however, the look and feel is somewhat different. The improved form has more functionality and is easier to use. Following is a summary of the changes:

Block 1, Item 7 – The total invoice amount is now an automatic calculation. This item will be automatically updated each time you complete a new line in Block 2.

Save and Exit – You may now save your work and exit the system without submitting the Form 474. You may then return at a later time to complete and submit the form. To access an incomplete form, you will need the invoice number and security code that was supplied to you after you first completed Block 1. Once you have submitted a Form 474, you may not make any changes to that form. However, you may still view your Form 474 at any time using the invoice number and security code.

Question/Problem – Click this button to submit a problem or comment about the Form 474 to the Client Service Bureau.

Print Preview – When you click the Submit button, the Print Preview function will display a copy of your Form 474. You may print your form at any time using the Print Preview function.

Block 2 Line Item Summary – As you add each line item, the Block 2 total will be updated.




