4 This is a pre-hearing conference in WT Docket
5 No. 07-110, involving the application of David
6 O. Castle for renewal of his license for
7 amateur radio service station WA9KJI.

8 By Hearing Designation Order DA07-
9 2185 released May 24, 2007, this case was
10 designated for hearing.

11 The issues seek to determine
12 whether Mr. Castle willfully and/or repeatedly
13 violated the Communications Act and a number
14 of Commission rules, to determine the effect
15 on Mr. Castle's qualifications of his use of
16 his amateur license to engage in criminal
17 behavior; to determine in light of the
18 evidence adduced whether Mr. Castle is
19 qualified to be and remain a Commission
20 licensee; and to determine whether Mr.
21 Castle's application for renewal of license
22 should be granted.

1 By Order FCC 07M-17, released June
2 1, 2007, this case was assigned to me, and a
3 date for a pre-hearing conference was set.

4 By Order FCC 0M-23, the date of
5 the pre-hearing conference was changed to this
6 morning.

7 Let me first take the appearances
8 for the parties. On behalf of David O. Castle?

9 Let the record reflect no
10 response.

11 On behalf of the Chief Enforcement
12 Bureau.

13 MR. KNOWLES-KELLETT: Bill
14 Knowles-Kellett.

15 JUDGE STEINBERG: Okay. Section
16 1.221C of the Commission's rules, and
17 Paragraph 12 of the Hearing Designation Order,
18 required Mr. Castle to file a written
19 appearance stating that he will appear on the
20 date fixed for hearing, and present evidence
21 on the specified issues.

8 No written Notice of Appearance
9 has been filed, and no one has entered an
10 appearance on behalf of Mr. Castle at this
11 conference.

12 Although the Commission has
13 received a number of communications by and on
14 behalf of Mr. Castle, none of them constitutes
15 the written appearance required by the
16 Commission's rules, and none of them has been
17 filed in the manner specified in those rules.

4 As I said, the 5/23/07 date
5 presumably refers to the HDO, which was
6 adopted on May 23, 2007.

7 No where in this submission does
8 Mr. Castle state that he will appear on the
9 date fixed for hearing and present evidence on
10 the issues specified in the HDO.

11 Mr. Knowles-Kellett, do you have
12 any objection to the receipt of Judge's
13 Exhibit 2 into evidence?

14 MR. KNOWLES-KELLETT: No
15 objection, Your Honor.

16 JUDGE STEINBERG: Okay, Judge's
17 Exhibit 2 is received.

19 page four is a letter that Donna Dill,
20 apparently, wrote to the Enforcement Bureau,
21 Spectrum Enforcement Division, Gettysburg, on
22 July 18, 2007.

1 Any objection to the receipt of

3 MR. KNOWLES-KELLETT: No, Your
4 Honor.

5 JUDGE STEINBERG: Okay, Judge's
6 Exhibit 3 will be received.
