This letter is submitted on behalf of Inmarsat Finance III Limited ("Inmarsat Finance") as a supplement to the October 16, 2007 response to the International Bureau's questions of October 10, 2007 regarding the ownership of shares of Inmarsat plc.

In late October, 2007, Inmarsat plc was notified that, in recent trading on the London Stock Exchange, Harbinger Capital Partners Master Fund I, Ltd. and Harbinger Capital Partners Special Situations Fund, L.P., both WTO Member country-based entities to the best of Inmarsat's knowledge, acquired, in aggregate, over 10 percent of Inmarsat plc shares. On October 26, 2007, Inmarsat plc was informed that these two funds own 51,034,999 shares, or approximately 11.2 percent.
