ERRATUM TO PETITION FOR RECONSIDERATION

West Virginia Media Holdings, LLC (“WVMH”), licensee of television station WBOY (analog channel 12, post-transition digital channel 12), Clarksburg, West Virginia (Fac. ID 71220), by and through its attorneys, hereby submits this *Erratum* to its electronically-filed October 26, 2007 Petition For Reconsideration of the Commission’s *Seventh Report and Order* (“7th R&O”)¹ in the above-referenced rule making proceeding.

It is respectfully noted that, at page 2 of the Engineering Statement at Exhibit E of the Petition For Reconsideration, reference is made to an attached map demonstrating the area of new interference to WBOY predicted to be caused by the allotment facilities for WMFD-DT, Mansfield, Ohio (Fac. ID 41893), adopted at Appendix B of the 7th R&O, as compared to the allotment facilities proposed for WMFD-DT at Appendix B of the underlying *Seventh Further Notice Of Proposed Rule Making*² in this proceeding. That map inadvertently was omitted from the electronic submission and is being submitted herewith promptly upon discovery.

WHEREFORE, WVMH hereby corrects the Petition For Reconsideration to include the attached map, and respectfully requests consideration of the map in connection with the Petition For Reconsideration.


