On behalf of the Public Safety Spectrum Trust Corporation ("PSST"), and its advisor, Cyren Call Communications Corporation ("Cyren Call"), and in accordance with Section 1.1206(b) of the Commission's Rules, 47 C.F.R. § 1.1206(b), this letter is to provide notification of a permitted *ex parte* communication regarding the above-identified Commission proceedings.

On November 5, 2007, Robert Gurss, representing the PSST, along with the following representatives of Cyren Call: Morgan O'Brien, Chairman of the Board; Tom Sidman, Executive Vice President – Business Processes; David Knutson, Vice President – Development; and undersigned counsel, met with Derek Poarch, Chief of the Public Safety and Homeland Security Bureau ("PSHSB"); Erika Olsen, PSHSB Deputy Bureau Chief; Tim Peterson, PSHSB Chief of Staff; and Jeff Cohen, PSHSB Senior Legal Counsel.

The parties discussed the Statement of Requirements ("SoR") being prepared initially by the National Public Safety Telecommunications Council in anticipation of the shared Public Safety-commercial broadband network to be deployed pursuant to the rules adopted in the above-identified proceedings and the inter-relationship of the SoR document to the Commission rules and policies articulated in the proceedings. The parties also discussed the Public Notice, DA 07-4514, released by the Commission on November 2, 2007, wherein the Commission revised its Default Payment procedures for the 700 MHz D Block and also provided further

guidance as to how the Commission intends to handle disputed issues in the negotiation of a Network Sharing Agreement between the 700 MHz D Block auction winner and the Public Safety Broadband Licensee.
