Dear Ms. Dortch:

Pursuant to the Commission's orders in the above-referenced proceeding, Time Warner Cable Inc. ("TWC") was required to certify compliance with the cable/SMATV cross-ownership restriction with respect to certain properties acquired in the subject transactions.<sup>1</sup> As of August 1, 2007, TWC had provided the requisite certifications for all but one Los Angeles area SMATV property subject to the rule.<sup>2</sup> The Media Bureau granted TWC until November 30, 2007 to complete interconnection and provide its certification of compliance relating to this final property.<sup>3</sup> TWC submits herewith a certification that interconnection of this property has now been completed.



I, Jose Leon, declare and affirm the following:

1. My declarations dated September 19, 2006; September 29, 2006; December 26, 2006; April 2, 2007; July 2, 2007; and August 1, 2007 that were submitted to the FCC in this proceeding are incorporated herein by reference.

2. As explained in the letter from Arthur H. Harding and addressed to the FCC Secretary to which this declaration is attached, Time Warner Cable Inc. ("TWC") was granted an extension until November 30, 2007 to achieve compliance with the cable/SMATV cross-ownership restriction with respect to the final SMATV property acquired in the subject transactions for which integration with TWC's surrounding franchised cable plant was required.

3. This is to certify that interconnection of that property has been completed.
