Dear Ms. Dortch:

Sirius Satellite Radio Inc. (“Sirius”), but its attorneys, files this letter pursuant to Section 1.65 of the Federal Communications Commission’s (“FCC”) rules<sup>1</sup> to update information concerning the pending application to transfer control (the “Consolidated Application”) in the above-referenced proceeding.

The Consolidated Application was filed on March 20, 2007, and included a request for the transfer of control of any license or authorization issued to XM or Sirius during the period prior to grant of the Consolidated Application.<sup>2</sup> A new space station license for Sirius FM-5 (S2710) was granted to Sirius after the Consolidated Application was filed – on April 16, 2007.<sup>3</sup> Sirius respectfully requests that the FCC take the new license into account in its processing of the Consolidated Application. In addition, Sirius is simultaneously filing an informational Form 312
