

***Parties to the Transaction:*** The parties involved in the transaction are Manhattan Telecommunications Corporation d/b/a Metropolitan Telecommunications (the assignee) and Capital Telecommunications, Inc. (the assignor).

CTI currently provides competitive local exchange, long distance (domestic and international), and data services to its subscribers. MetTel will provide the same services to these subscribers.


***Date of Transfer of the Subscribers to Acquiring Carrier:***

CTI intends to transfer the affected subscribers to MetTel on January 10, 2008 or as soon thereafter as all necessary regulatory approvals have been obtained.

### IMPORTANT NOTICE REGARDING YOUR TELEPHONE SERVICE

Dear CTI Customer:

We are happy to share some exciting news about your telecommunications services. We are proud to announce that, during January 2008, your telecommunications services formerly provided by CTI, will be provided by Metropolitan Telecommunications (MetTel).

MetTel is a nationwide integrated telecommunications provider serving customers with local and long distance telephone services, Internet access and a full suite of complex voice and data services throughout the 48 contiguous states and the District of Columbia. MetTel's mission has always been to deliver bottom-line value to customers through a commitment to outstanding customer service and product excellence. Our goals are simple: deliver superior customer service and provide high quality telecommunications solutions.

#### **No action on your part is required**

As a MetTel customer, your telephone numbers will remain unchanged and you will continue to receive your same services at the same rates, terms and conditions as at present. There will be no fees applied in connection with the transfer of your service to MetTel. Notice of any future changes in rates, terms and conditions of service will be provided to you as required by law.

**MetTel anticipates that the date for the transfer may be on or about January 10, 2008 depending on when the necessary state and federal regulatory approvals are obtained.** Again, no action is required on your part and your service will continue with MetTel at the same rates.
