

Dear Ms. Dortch:

The DIRECTV Group ("DIRECTV") hereby submits additional documents in response to the Commission's Initial Information and Document Request dated June 15, 2007 (the "Request"). We are continuing to review the documents collected from the sources identified to the Commission and will produce responsive documents on a rolling basis as quickly as possible.

This production follows the same organizational procedures outlined in the letter accompanying DIRECTV's production of August 3, 2007. Specifically, to facilitate handling of the documents in keeping with the two protective orders in this proceeding, they are organized so that the entire contents of each box have the same level of confidentiality. Thus:
