The Region 47 (Puerto Rico) Public Safety Regional Planning Committees will hold two consecutive planning meetings on Tuesday, January 29, 2008. All eligible public safety providers whose sole or principal purpose is to protect the safety of life, health, or property in Region 47 may utilize these frequencies. It is essential that public safety agencies in all areas of government, including state, municipality, and non-governmental organizations eligible under Section 90.523 of the Commission's rules, be represented in order to ensure that each agency's future spectrum needs are considered in the allocation process. Administrators who are not oriented in the communications field should delegate someone with this knowledge to attend, participate, and represent their agency's needs.
