Roy E. Henderson (hereinafter "Henderson"), pursuant to Sections 1.415(d) and 1.65 of the Commission's Rules, hereby files the instant "Motion for Leave to File Factual Update" in this proceeding.


On Monday, February 11, 2008, Henderson Filed a "Comments and Counterproposal" requesting allotment of a new FM channel to Buffalo, Texas, which at that time had no existing aural services. Subsequently, by Public Notice Report No. 46672, released February 13, 2008, the FCC announced grant of an educational noncommercial station to be located in Buffalo. Since recognition of this new fact is relevant (although not determinative) to this proceeding, Henderson believes that it should be brought to the Commission's attention here to assure a full and accurate record in the case and as also required by FCC rule 1.65 to maintain representations factually up-to-date and accurate.


