Dear Ms. Dortch:

This is to inform you that on March 31, 2008, Jay Monahan, General Counsel of Vuze, Inc. ("Vuze") and the undersigned met with Dana Shaffer, Chief of Wireline Competition Bureau and the Bureau staff members listed in the attachment to this letter. The purpose of the meeting was to provide the Bureau staff with a demonstration of the Vuze application and technology, similar to the demonstration given by Vuze CEO Gilles BianRosa at the Commission hearing on Feb. 25, 2008 in Cambridge, MA.

We also addressed briefly the recent announcement that Comcast and BitTorrent, Inc. had agreed to collaborate to address network management issues. We noted that while Vuze welcomes efforts at industry cooperation, it has not changed its position with respect to the Petition for Rulemaking it filed last November. The Comcast/BitTorrent, Inc. agreement is between one network operator and one online content company, BitTorrent, Inc. does not represent the entire community of companies that use the BitTorrent protocol in their Internet applications. In contrast, Vuze seeks general rules regarding reasonable network management that would apply to all network operators and

would enable industry-wide cooperation among network operators, online content companies, and consumer representatives.
