DTV Consumer Education Quarterly Activity Report

Instructions

This form must continue to be filed for each quarter in which a station has DTV Transition education obligations.

This requirement will increase to two PSAs and crawls per quarter per day on April 1, 2008, and to three of each on October 1, 2008. Stations are required to air PSAs or crawls at various times in any given day part, and at least one PSA and one crawl per day must be run during primetime hours. On-air education must not contain inaccurate or misleading statements and must be provided in the same language as a majority of the programming carried by the station. PSAs must be at least 15 seconds, and closed-captioned. Crawls must run during programming for no fewer than 60 consecutive seconds across the bottom or top of the viewing area (See rules for additional details).

KRBC-TV jumped into the DTV conversion process early. We launched weekly news series beginning on January 17, 2008. KRBC’s segment runs every Tuesday in the 5pm News and is entitled “Digital 101.” The segment covers various issues related to the conversion and directs viewers to learn more details on our web site Bigcountryhomepage.com. The segment ran a total of 11 times in the 1st Q. In conjunction with our news segments we launched an area on our website called “DTV Answers.” In this area, we have all the most asked questions with answers, as well as a video player with 8 different commercials for users to watch. This area also includes a list of local market DTV education efforts as well as a countdown clock to the conversion deadline. A “DTV Answers” banner ad also runs throughout our web site. We elected not to use the supplied NAB spots because they were too generic and allowed no local way to relate to our viewer.

In late December 2007, Mission Broadcasting, Inc. began creating a full DTV Awareness and Educational campaign to be implemented at each of our stations on February 17, 2008. The goal was to get out in front of our competitors to be THE local source for DTV education. Emphasizing localism was key in providing eight generic spots relating to various aspects of the conversion that could be customized with their local news talent or manager as well as the creation of customized websites for each station. We elected not to use the NAB supplied spots because they were too generic and allowed no local way to relate to our viewers. Each of our spots pushed viewers to the stations' respective local websites for more information, including forums for local discussions. We included areas to add specific information related to that local market's DTV education efforts as well as a countdown clock to the conversion deadline. We're addressing outreach in other areas as well, for example, for the non-web-savvy elderly population. We have created customized brochures for each market that can be mailed or picked up at the each station. These are also used in trade show displays as well as local DTV speaking engagements. We took it one step further by creating the same brochure in Spanish for each market if so requested
