DTV Consumer Education Quarterly Activity Report

Instructions

This form should be used to provide the Federal Communications Commission (FCC) with information pertaining to all station activity to educate consumers on the transition to digital television (DTV). All stations should log DTV Transition-Related Public Service Announcements (PSAs) and other DTV activities using the appropriate house (identification) numbers. These logs or records should include the date and time that each DTV activity occurred. This form must be filed in Docket Number 07-148 as Document Type: REPORT, and placed in the station's Public Inspection File. This form must continue to be filed for each quarter in which a station has DTV Transition education obligations.

On its analog channel, and its primary digital stream, a station must air one transition PSA, and run one transition crawl, in every quarter of every day. This requirement will increase to two PSAs and crawls per quarter per day on April 1, 2008, and to three of each on October 1, 2008. Stations are required to air PSAs or crawls at various times in any given day part, and at least one PSA and one crawl per day must be run during primetime hours. On-air education must not contain inaccurate or misleading statements and must be provided in the same language as a majority of the programming carried by the station. PSAs must be at least 15 seconds, and closed-captioned. Crawls must run during programming for no fewer than 60 consecutive seconds across the bottom or top of the viewing area (See rules for additional details).

On January 1, 2008, WKEF aired a news story on the DTV conversion in the 11:00pm newscast. This was the content:

"For some, a state of the art television is a must have.... For others....any old thing that has a picture will do... But as of february 2009....it won't do.
Those who use over the air signal, if you use an antenna indoor or outdoor, you will no long be able to recieve analog broadcast over the air unless you have a digital television or a digital conversion box.
One popular question that comes up....what if i subscribe to cable or satellite service? You won't be affected...
The decision to make the switch was made by the federal government back in 1996....but the hard deadline was set after 9/11....during that disaster police and fire communications channels became clogged. They're going to analog, that's why they're dropping tv off that to free up the full bandwidth there.
But the federal government isn't leaving consumers out in the cold....they've put aside one-point-five billion to help people purchase digital coverter boxes...that means each household can get up to 2, forty dollar coupons to put toward their digital converterthey will be available at electronics retailers next month and cost 50 to 70 bucks."
