### DTV Consumer Education Quarterly Activity Report

**Instructions**

This form should be used to provide the Federal Communications Commission (FCC) with information pertaining to all station activity to educate consumers on the transition to digital television (DTV). This form must continue to be filed for each quarter in which a station has DTV Transition education obligations.

On its analog channel, and its primary digital stream, a station must air one transition PSA, and run one transition crawl, in every quarter of every day. This requirement will increase to two PSAs and crawls per quarter per day on April 1, 2008, and to three of each on October 1, 2008. Stations are required to air PSAs or crawls at various times in any given day part, and at least one PSA and one crawl per day must be run during primetime hours. On-air education must not contain inaccurate or misleading statements and must be provided in the same language as a majority of the programming carried by the station. PSAs must be at least 15 seconds, and closed-captioned. Crawls must run during programming for no fewer than 60 consecutive seconds across the bottom or top of the viewing area (See rules for additional details).

"Cuenta Regresiva Hacia- DTV Estas Listo?" ("Countdown to DTV: Are you Ready?) aired on March 22, 2008 at 6:30 AM. The special reviewed the differences between analog and digital broadcasting, highlighted the benefits of digital broadcasting, demonstrated how the converter box works and explained the importance of applying for digital-to-analog converter box coupons. The Univision Network transmitted a half hour special, entitled "TV Digital...¿Que Tal?" ("Digital TV...What Is It?"), on February 2, 2008, at 11:00 am. The program explained in easy to understand terminology the differences between analog and digital broadcasting and detailed the government's coupon program for the purchase of digital-to-analog converter boxes. The Univision Network transmitted another half hour special, entitled "TV Digital...¿Cuanto Sabes?" ("Digital TV... How Much Do You Know?"), on March 22, 2008, at 4:30 pm, and again on March 30, 2008 at 1:30 am. The special, hosted by and featuring various Univision Network personalities, again reviewed the differences between analog and digital broadcasting, highlighted the benefits of digital broadcasting, explained the importance of applying for digital-to-analog converter box coupons and demonstrated, step-by-step, how to properly install a converter box.

Stations must execute a minimum of one "Countdown to DTV" on-air activity per day during the 100 days leading up to February 17, 2009. Beginning May 1, 2008, this requirement doubles, and beginning November 1, 2008, it increases again, to 180 seconds per day and 22.5 minutes per month between 6 pm and midnight. It must also run one 30 minute transition education piece once (See rules for additional details).


