This, in the name of streamlining traffic flow through its network of cable connections. I'm sure we all understand Comcast's motives, here. Their network was never designed to handle the volumes of traffic called for by P2P node-nets, which expect a wide pipe to be open continually for each node (user system). Comcast's answer appears to be to try to squeeze the benefit out of the P2P scheme for its own users (and add to the cumulative traffic on the rest of the network, as well) by deflecting packet requests around its own systems.
