REPLY COMMENTS

Liberian Broadcasting of Dallas License LLC ("Liberian"), licensee of Station KZMP-FM, Pilot Point, Texas, hereby submits its Reply Comments to the Public Notice released on May 5, 2008.¹ The Public Notice seeks comment on a Counterproposal filed by Liberian in the above captioned proceeding. Liberian filed the Counterproposal as part of a hybrid filing to upgrade KZMP-FM from Channel 285C1 to Channel 285C0 at a new site (*see* BPH-20071126AJG). The allotment of Channel 285C0 to Pilot Point was short spaced to the proposal in this proceeding to allot Channel 286A at Hugo, Oklahoma.² Thus, in addition to filing a Form 301 application, Liberian submitted its proposal as a Counterproposal in this proceeding pursuant to the Commission's new procedures.³

² The allotment of Channel 285C0 to Pilot Point is also short spaced to (i) vacant Channel 285A at Hico, Texas, (ii) vacant Channel 285A at Broken Bow, Oklahoma, and (iii) a pending rule making to allot Channel 284A to Antlers, Oklahoma (MB Docket No. 07-182). Regarding vacant Channel 285A at Hico, Texas, Liberian requested in its Counterproposal to change the channel and site of this allotment from Channel 285A to Channel 293A. Regarding vacant Channel 285A at Broken Bow, Oklahoma, Liberian proposed in its concurrently filed Form 301 application to change the allotment's reference coordinates. Finally in order to cure the short-spacing to the rule making to allot Channel 284A to Antlers, Oklahoma, Liberian concurrently filed a Counterproposal in that proceeding.

On April 10, 2008, Katherine Pyeatt, the proponent for Channel 286A at Hugo, Oklahoma, withdrew her expression of interest. No other party filed an expression of interest in the allotment of Channel 286A at Hugo. Thus, because “it is the Commission's policy to refrain from making an allotment to a community absent an expression of interest,” the Commission should not allot Channel 286A to Hugo.⁴ This leaves Liberman’s proposal for KZMP-FM as the remaining proposal in this proceeding. Liberman hereby confirms its continuing interest in the Counterproposal and the related KZMP-FM upgrade application and respectfully requests that the Commission grant this proposal. It will provide new aural service to 1,407,008 persons, which serves the public interest.⁵


For the foregoing reasons, Liberman respectfully requests that the Commission (i) grant the concurrently filed Form 301 application to upgrade KZMP-FM from Channel 285C1 to Channel 285C0, (ii) change the reference coordinates of vacant Channel 285A at Broken Bow, Oklahoma, as requested in the KZMP-FM application, and (iii) change the channel of the vacant allotment at Hico, Texas from Channel 285A to Channel 293A in this proceeding. Liberman also requests expedited action on this rule making and the KZMP-FM upgrade application, which is warranted given the fact that its proposal for KZMP-FM is the only remaining proposal in this proceeding.
