On May 21, 2008, representatives of Intrado Communications Inc. ("Intrado Comm") - Susan A. McGurkin, Director of Federal Government & Regulatory Policy, Natalie Baker, Director of Regulatory Affairs, and the undersigned - met with Dana Shaffer, Chief of the Wireline Competition Bureau ("WCB"), Nicholas Alexander of the Telecommunications Access Policy Division of the WCB, Randy Clarke, Legal Counsel to the WCB Chief, and Erika Olsen, Deputy Bureau Chief of the Public Safety & Homeland Security Bureau.

The participants discussed Intrado Comm's efforts to obtain Section 251(c) interconnection with incumbent local exchange carriers in various states and how its experiences relate to the pending petition for declaratory ruling concerning AT&T's merger commitment 7.1. Intrado Comm also discussed the importance of having the Commission act expeditiously to grant Intrado Comm's preemption request because interconnection arrangements with the incumbent local exchange carriers are essential to Intrado Comm's provision of local exchange services, including its competitive advanced 911 service offering to public safety answering points and other public safety
