

Declaration of Jennifer Matarangas-King

1. My name is Jennifer Matarangas-King. I am President of Caribbean Communications Corp. (d/b/a Innovative Cable-TV - St. Thomas-St. John) and St. Croix Cable TV, Inc. (d/b/a Innovative Cable TV - St. Croix) (collectively, "Innovative Cable TV"). I declare under penalty of perjury that the facts contained in this Declaration are true and correct to the best of my knowledge, information and belief, and that I am authorized to give this Declaration on behalf of Innovative Cable TV.
2. Pursuant to the Memorandum Opinion and Order, DA 08-438, issued by the Media Bureau in the above-referenced proceeding on March 19, 2008, and pursuant to the Declaration filed by the undersigned in the above-referenced proceeding on March 21, 2008, Innovative Cable TV: (a) has notified its analog customers of its plans to transition to an all-digital network on or before February 17, 2009; and (b) has in its inventory, or has placed orders for, enough set-top boxes to ensure that each of its customers can continue to view its video programming on their television sets after the transition.
