
On or about August 7, 2007, our firm served notice on the Federal Communications Commission ("Commission") providing that Choicetel, Inc. ("Choicetel") intended to terminate the blanket interstate operating authority granted to Choicetel by the Commission. A copy of this notice appears as Exhibit A hereto.

We have had numerous conversations with Commission staff concerning the attached notice. We write this letter in an effort to clarify our previous transmittal.

The Commission granted Choicetel's Transfer of Control Application in January 2007. (Docket No. ITC-ASG-20061201-00542). Choicetel ceased operations and discontinued service with the granting of the properly filed application. As such, we agree with Commission staff that Choicetel's blanket interstate operating authority terminated with the proper filing of the Transfer of Control Application in WC Docket No. 06-217, and that no request to discontinue or terminate blanket interstate operating authority need be filed by Choicetel at this time.




Accordingly, we respectfully request that the Commission cancel Choicetel's authority effective immediately.
