

1. My name is Charles Crawford and I filed a Petition for Rule Making proposing to allot channel 294A to Cross Plains, Texas on or about May 27, 2003. Based on my expression of interest, the FCC subsequently released a Notice of Proposed Rule Making, MB Docket No. 04-348, on September 3, 2004. And finally, on February 3, 2005, the FCC released a Public Notice which combined Docket No. 04-348 with Docket No. 04-407.

I have decided not to pursue the allotment of channel 294A at Cross Plains, Texas at this time and have therefore concluded to request that the FCC dismiss my Petition for channel 294A at Cross Plains, Texas.
