Sprint is the Telecommunications Relay Service (TRS) provider in the State of Missouri. As mandated by the Federal Communications Commission (FCC), pursuant to 47 C.F.R. § 64.604(c)(1)(i), Sprint has maintained a log of all consumer complaints that allege a violation of the federal minimum standards for TRS. Sprint has forwarded this log, including the date and nature of the complaint, the date and explanation of its resolution to Missouri Public Service Commission Staff. The time period covered by this log is from June 1, 2007 through May 31, 2008.

This complaint log summary is being filed with the FCC pursuant to 47 C.F.R. § 64.604(c)(1)(ii) which requires "states and TRS providers shall submit summaries of logs indicating the number of complaints received for the 12-month period ending May 31 to the Commission by July 1 of each year."
