

I hereby vehemently speak out AGAINST this proposed legislation as it has the very real likelihood of endangering our FREEDOM of SPEECH guaranteed in our Constitutional 1st Amendment. In addition to the myriad requirements, regulations, etc, implied or imposed by this proposed legislation, I also STRONGLY oppose the re-introduction by Congress of the repealed "Equal Time" Fairness Doctrine, with the FCC forcing broadcasters to air "both sides" of controversial issues.

Make no mistake. I am a God fearing Christian who firmly and fully believes in Jesus Christ of Nazareth as Lord and Savior of all that choose to hear and acknowledged his voice and accept his grace, forgiveness, mercy and redemption. I am fully aware that there are innumerable members of our community and indeed our country who do not wish to hear that information. However, if I do not force my beliefs on them, I do not believe they have the right through LAW to force them on me.
