Section II: Additional Information Require by §63.04

Number 7) IBFA Acquisition Company, LLC is a non-facilities-based non-dominant carrier that offers intrastate and interstate long distance services through the resale of purchased services from various facilities-based carriers. The Company is authorized through blanket authority by the FCC to offer domestic interstate telecommunications services in the fifth (50) states and the District of Columbia as a non-dominant carrier. In addition, the company has authority to provide intrastate services as indicated in Attachment A.

Number 8) This Application qualifies for streamlined processing under Section 63.03(b)(1)(ii) because the transferee is not a telecommunications provider.
