Sirius XM Radio Inc.,¹ by its counsel and pursuant to Sections 1.948(d), 5.79 and 25.119(f) of the rules of the Federal Communications Commission (“Commission”),² hereby notifies the Commission that on July 28, 2008, the transaction approved in the FCC Order adopted on July 25, 2008 (“*Sirius/XM Order*”)³ was consummated.
